

as established by the valuation rolls in force at the time of such division.

**8.** The municipality of Ivry-on-the-Lake is hereby authorized to borrow the sum of five thousand dollars for the purposes of paying the expenses of incorporation and for paying immediately to the municipalities of the parishes of St. Agathe des Monts and of St. Faustin, its proportion of any liabilities that may exist, the balance to be used for local improvements as the council may deem fit and proper. Loan for certain purposes.

**9.** Notwithstanding article 283 of the Municipal Code, every person who has resided in the municipality for three months in the year preceding the elections and possesses the other qualifications required, shall be qualified to fill the position of municipal councillor or any other municipal officer. Qualification for councillors.

**10.** The office of the municipality and that of the secretary-treasurer may be in the village of Ste. Agathe des Monts. Office of municipality, &c.

**11.** This act shall come into force on the day of its sanction. Coming into force.

## CHAP. 79

An Act respecting the parish of St. Dunstan of Lake Beauport.

[Assented to 14th March, 1912.]

**W**HEREAS, John Murphy, Charles E. Smith, Peter McNeil Preamble.  
Simons, William Sangster and George Jewell, all farmers, of the parish of St. Dunstan of Lake Beauport, in the county of Quebec, have, by their petition represented, that they, with other proprietors and ratepayers, already form part of the municipality of St. Dunstan of Lake Beauport, erected by proclamation dated the 15th June, 1853; that the inhabitants of that place are in great majority English speaking and of English origin and that, in consequence of the religious and civil erection of the parish of Notre-Dame des Laurentides, their number has been decreased to less than three hundred souls and they have lost their existence as a separate corporation;

Whereas there may be doubts whether the county council can incorporate the inhabitants of the said territory as a distinct municipality;

Whereas it is expedient, in view of the exceptional circumstances in which the petitioners are placed, to erect the territory

in question into a separate municipality and to declare that it has never ceased to exist as such;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Parish of St. Dunstan of Lake Beauport to continue to exist as separate municipality.

**1.** Notwithstanding any law to the contrary, the corporation of the parish of St. Dunstan of Lake Beauport has always existed since its erection into a parish municipality, and shall continue to exist as a separate municipal corporation, even if the population of the territory has not in the past and does not in the future attain the number of three hundred souls.

Boundaries of parish.

**2.** The territory of the municipality of St. Dunstan of Lake Beauport, as erected by proclamation dated the 15th June, 1853, shall comprise the following territory:

(a) The portion taken from the seigniory of Beauport, comprising the first range from Nos. 79 to 119 inclusive; the second, third, fourth, fifth, sixth and seventh ranges from Nos. 120 to 289, inclusive of the official cadastre of the municipality of St. Dunstan of Lake Beauport; such territory taken from the seigniory of Beauport contains an area of about three and a half miles in front, by an average depth of five miles, forming in all an area of about seventeen and a half square miles;

(b) The portion taken from the parish of Charlesbourg, comprising the concession called "Le Brulé," the fourth concession, called "La Montagne des Ormes," the fifth concession called "Neigette"; the sixth, seventh and eighth concessions, forming a series from Nos. 1 to 28, inclusive, of the official cadastre of the municipality of St. Dunstan of Lake Beauport; such territory taken from the parish of Charlesbourg forms an area of about a mile and a half in front by about five miles in depth, forming an area of about seven and a half square miles.

As so constituted and bounded, the territory of the municipality of St. Dunstan of Lake Beauport, shall have a total almost quadrangular area of about 25 square miles, and bounded as follows:

To the north-west by the first range of the parish of St Edmond de Stoneham, comprising the Nos. 8, 9, 10, 11, 11a, 12, 12a, 13, 14, 15, 16, 16a, 17, 18, 19, 20, 21, 22, inclusively of the official cadastre of the said parish as canonically erected by the decree dated 28th January, 1850.

To the north-east, by the No. 432 of the fourth range of

the official cadastre of the parish of Ste. Brigitte de Laval, formerly of the seigniorship of Beauport.

To the south-east, partly by St. André concession of the parish of Beauport, partly by the Nos. 849, 848, 847, 846, 844, 843, 841, 840, 839, 838, 837, 836, 835, 829, 828, 827, 826, 825, 824, 823, 822, 821, 820, 819, 818, inclusively, of the official cadastre of the parish of Charlesbourg, formerly of the concession de la Montagne des Ormes in the fief Grandpré, partly by Nos. 817, 816, partly by the Nos. 815 as far as No. 806 inclusively of the official cadastre of the parish of Charlesbourg, formerly in the fief Begon.

To the south-west partly by the No. 849 of the concession called "La Montagne des Ormes," formerly in the fief Grandpré, partly by the No. 817, partly by the No. 815, both of the official cadastre of the parish of Charlesbourg, in the fief Bégon partly by the Nos. 793, 794, 805 (formerly in the fief de la Trinité), of the parish of Charlesbourg, partly by the Nos. 10, 11, 22, 23, 26, of the official cadastre of the parish of St. Edmond de Stoneham, formerly in the fief de la Trinité."

**3.** The first general election of the council for the said First general election. municipality shall take place within thirty days from the sanction of this act and shall be presided over by the person chosen by the majority of the electors present at the meeting; and subsequent elections shall be held on the date and in the manner provided by the Municipal Code.

**4.** The costs, fees and disbursements incurred by the passing Costs of this act. of this act shall be at the charge of the municipality of St. Dunstan.

**5.** This act shall come into force on the day of its sanction. Coming into force.

## C H A P . 8 0

An Act to amend the act erecting the parish of St. Michael the Archangel of Montreal as a separate school municipality.

[Assented to 14th March, 1912.]

**W**HEREAS the corporation of Catholic School Trustees Preamble. of the separate schools of the parish of St Michael the Archangel of Montreal, has by its petition represented, that the revenues it can now derive under its charter do not suffice to meet the needs of the corporation and it would be right that all proprietors, occupants, tenants or ratepayers
