To the south-west partly by the No. 849 of the concession called "La Montagne des Ormes," formerly in the fief Grandpré, partly by the No. 817, partly by the No. 815, both of the official cadastre of the parish of Charlesbourg, in the fief Bégon partly by the Nos. 793, 794, 805 (formerly in the fief de la Trinité), of the parish of Charlesbourg, partly by the Nos. 10, 11, 22, 23, 26, of the official cadastre of the parish of St. Edmond de Stoneham, formerly in the fief de la Trinité."

3. The first general election of the council for the said First general election. municipality shall take place within thirty days from the sanction of this act and shall be presided over by the person chosen by the majority of the electors present at the meeting; and subsequent elections shall be held on the date and in the manner provided by the Municipal Code.

4. The costs, fees and disbursements incurred by the passing Costs of this act. of this act shall be at the charge of the municipality of St. Dunstan.

5. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 8 0

An Act to amend the act erecting the parish of St. Michael the Archangel of Montreal as a separate school municipality.

[Assented to 14th March, 1912.]

WHEREAS the corporation of Catholic School Trustees Preamble. of the separate schools of the parish of St Michael the Archangel of Montreal, has by its petition represented, that the revenues it can now derive under its charter do not suffice to meet the needs of the corporation and it would be right that all proprietors, occupants, tenants or ratepayers

professing the Catholic religion and speaking the English language who reside within the limits of its school municipality should pay their school taxes and assessments to the said corporation and that the said corporation should derive its share of the taxes collected from corporations, and it is expedient to grant its prayer:

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

6 Ed. VII, c. 86, s. 1, replaced. **1.** Section 1 of the act 6 Edward VII, chapter 86, is replaced by the following:

Persons to form school corporation.

“**1.** Any number of proprietors, occupants, tenants or ratepayers professing the Catholic religion, speaking the English language, in any of the following school municipalities to wit: Ville St. Louis, and St. John of the Cross both in Laurier ward of Montreal, St. Denis, St. Edward's, and the municipality of Villeray, all of St. Denis ward of Montreal, and the town of Outremont, all in the island of Montreal, or any other school districts that may be formed of any portion or portions of any of the above-named school districts, shall, until the said school districts or school municipalities form part of the city of Montreal for school purposes, constitute a separate corporation under the administration of three special trustees, which said corporation shall be called “The Corporation of Catholic Trustees of the separate schools of the parish of St. Michael the Archangel of Montreal” and the latter may establish and maintain one or more separate schools in the territory above mentioned.”

Id., ss. 3, 5, repealed. **2.** Sections 3 and 5 of the act 6 Edward VII, chapter 86, are repealed.

Corporation to receive share of certain assessments.

3. The Corporation of the Catholic Trustees of the separate schools of the parish of St. Michael the Archangel of Montreal, shall receive from the school municipalities from whose control they are detached, a share of the assessments levied and collected on the immoveable property of corporations and incorporated companies in such proportion, as regards the amount collected in the said school districts, as the number of children attending its schools bears to the total number of children attending the schools of the said school districts.

Coming into force.

4. This act shall come into force on the day of its sanction.
