

That it is to the evident advantage and in the interest of the said James Hugh Brodie Allan and Margaret Jane Allan, the universal legatees in ownership, as well as of the said Dame Agnes Watson to enter into the said lease;

And whereas it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**Certain lease authorized.** 1. The said Dame Agnes Watson is authorized to lease for the term of twenty-one years from the first day of May, 1912, to the said Johnston Bros, their successors or assigns, the immoveable property known as No. 1341 on the official plan and book of reference of the St. Antoine ward, of the city of Montreal. Should the said substitution open before the execution of the said lease the curator to the said interdicts is authorized to execute the same.

**Coming into force.** 2. This act shall come into force on the day of its sanction.

## C H A P . 1 4 6

An Act to authorize the Bar of the Province of Quebec to admit Maurice Brasset, among its members, after examination.

[Assented to 14th March, 1912.]

**Preamble.** **W**HEREAS Maurice Brasset, of Quebec, has, by his petition represented:

That he followed a regular course of study at the college of Ste-Anne de la Pocatière, where he obtained the degree of Bachelor of Arts;

That, in the month of September, 1907, he entered Laval University, at Quebec, and followed the course of law lectures for two years;

That he was admitted to the study of law only in the month of January, 1910, and without the benefit of an act authorizing the Bar to admit him among its members, after examination, he will suffer delay which will be prejudicial to him;

That under notarial deed of indenture he has attended the office of Mr. Hector Laferté, advocate, of Quebec, since the month of September, 1909;

That the General Council of the Bar of the Province of Quebec has approved a petition setting forth the provisions of this act;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to admit the said Maurice Brasset among its members after successfully passing his examination. Bar of P. Q. authorized to admit M. Brasset.
2. This act shall come into force on the day of its sanction. Coming into force.

#### C H A P . 1 4 7

An Act to authorize the Bar of the Province of Quebec to admit Paul Antonio Decary amongst its members after examination.

*[Assented to 14th March, 1912.]*

**W**HEREAS Paul Antonio Decary, of the city and district of Montreal has by his petition represented : Preamble.

That he is twenty-three years of age ;

That he finished his course of classical studies at St. Mary's College, in Montreal, in June 1908 ;

That immediately afterwards he began to study law in the office of Messrs. Décarie and Décary, advocates, of the city and district of Montreal ;

That since June 1908, he has continuously attended the office of the said Messrs. Décarie and Decary ;

That, on the 18th August 1909, he was indentured to Mr. Alphonse Décary, one of the members of the said legal firm, by deed of indenture signed before Mr. E. R. Décary, notary;

That, in September 1909, he began to follow the lectures of the law faculty of Laval University in Montreal, and has since then been a student of the said faculty of the said university ;

That he has so far passed all his university examinations ;

That in January 1910, he presented himself before the Board of Examiners of the Bar to undergo the examinations for admission to the study of law and that, at such examination, he was admitted in letters ;

That he passed his examination in sciences in January 1911;

That he wishes to be admitted as a member of the Bar of the Province of Quebec after passing his examination for admission to the practice of law ;

Whereas the General Council of the Bar of the Province of Quebec has approved of the passing of an act to authorize the petitioner to be admitted among the members of the said
