

Bar immediately after passing the examination for admission to the practice of law ;

And whereas it is expedient to grant the prayer to the above effect contained in the said petition.

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Admission of P. A. Decary to Bar. **1.** The Bar of the Province of Quebec is hereby authorized to admit the said Paul Antonio Decary to the final examination for admission to the practice of law and after he has passed such examination to admit him among the members of the Bar of the Province of Quebec.

Coming into force. **2.** This act shall come into force on the day of its sanction.

#### CHAP. 148

An Act to authorize the Bar of the Province of Quebec to admit Demetrius Nicholas Nicholson amongst its members

*[Assented to 14th March, 1912.]*

Preamble.

**W**HEREAS Demetrius Nicholas Nicholson, of the city of Montreal, hath by his petition represented:

That he was admitted to the study of law, on letters, at the examination held in July, 1908, and on sciences, at the examination held in January, 1911;

That on the 15th day of September, 1908, he entered McGill University, Montreal, and there followed a regular course of law, and in May, 1911, obtained the degree of Bachelor of Civil Law;

That he has been under notarial indentures to Mr. Edouard Fabre Surveyer, King's Counsel, and to Mr. Alexander Chase Casgrain, both of the city of Montreal, since the 16th of October, 1908;

That he has successfully passed the examination for admission to the practice of the profession of advocate in July, 1911;

That he has obtained the approval of the General Council of the Bar of the Province of Quebec to a bill authorizing the said Bar to admit him to the practice of his profession, and the secretary of said council to grant him his certificate as an advocate from the time of the sanctioning of the said act by the Legislature;

Whereas the petitioner has prayed that an act be passed for the above purposes and it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council, and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to permit the said Demetrius Nicholas Nicholson to practise as an advocate, and the secretary of the General Council of the Bar to issue to him his certificate as an advocate. Bar of P. Q. authorized to admit D. N. Nicholson, &c.

**2.** This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 4 9

An Act to authorize the Bar of the Province of Quebec to admit George Williamson amongst its members after examination.

[Assented to 14th March, 1912.]

**W**HEREAS George Williamson of the city and district of Montreal has by his petition represented that he is a Bachelor of Arts of Harvard University, U. S. A., and that he is a Barrister at law of the Inner Temple, London, England, and that he is desirous of being admitted as a member of the Bar of the Province of Quebec after examination ; Preamble.  
 And whereas the General Council of the Bar of the Province of Quebec has approved of the petitioner's application and consented to the granting of the petition of the said petitioner ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The Bar of the Province of Quebec is hereby authorized to admit the said George Williamson among its members after sufficient examination. Bar of P. Q. authorized to admit G. Williamson.

**2.** This act shall come into force on the day of its sanction. Coming into force.
