

ed by the Academy of Music of Quebec. Such jury shall consist of five members, two of whom shall be taken from persons who are not members of the said Academy.

c. The competitor who obtains the highest number of marks, shall have the right to pass two years in Europe at the expense of the Academy of Music of Quebec, to complete his musical studies.

Who may be competitors. **2.** The only persons who may participate in the competition mentioned in the preceding article, are the holders of a laureate's degree from the Academy of Music of Quebec, being British subjects not more than twenty-five years of age, and residents of the Province for at least three years. The Academy of Music of Quebec, may, however, upon such terms as it thinks just, admit to the examinations for the laureate's degree, the pupils of other musical institutions in the Province.

Course of study. **3.** Holders of scholarships in order to receive the benefits conferred by this act, shall follow the course of studies prescribed by the Academy of Music of Quebec.

Coming into force. **4.** This act shall come into force on the day of its sanction.

CHAP. 6

An act respecting the National Battlefields at Quebec

[Assented to 24th March, 1911]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

8 Ed. VII, c. 3, s. 1a added. **1.** The act 8 Edward VII, chapter 3 is amended by adding after section 1 thereof the following :

Ceding of certain lands to Commission. **"1a.** The municipal council of any such municipality wherein the said battlefields are situated in part, may, with moneys advanced by the said commission and to be repaid to it by instalments covering a period of not more than thirty years, with interest of not more than three per cent, per annum, acquire and cede to the Commission, under such conditions as may be agreed upon, any lands required for the purposes mentioned in the preceding section, and may agree with the owners of immoveable properties adjoining

such lands, to lay or cause to be laid the water, drainage and other underground conduits along such lands but outside the boundaries thereof."

- 2.** This act shall come into force on the day of its sanction. Coming into force.

CHAP. 7

An Act to amend the act 1 George V, chapter 7, respecting the annexation of the parish of L'Ascension to the county of Ottawa for all purposes.

[Assented to 14th March, 1911]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

- 1.** Section 1 of the act 1 George V, chapter 7 is replaced by 1 Geo. V, c. 7, s. 1, repl. the following :

" **1.** The parish of L'Ascension in the county of Montcalm Parish of L'Ascension is detached from the said county and is annexed for registra- l'Ascension tion purposes to the registration division of the county of annexed to county of Labelle, for municipal purposes to the county municipality Ottawa. of Labelle, and for other purposes to the county of Ottawa."

- 2.** Section 2 of the said act is amended by inserting after Id., s. 2, am. the figures " 67 " in the first line the words " paragraph 30 of article 74 and paragraph 29 of article 75 ".

- 3.** This act shall come into force on the day of its sanction. Coming into force.
