Publications of regulations. All such regulations shall be published in the *Quebec Official Gazette*, and shall then have force of law.

Law to apply. **1631e.** The laws governing other Crown lands and forests, shall apply to such township forest reserves, except where they are inconsistent with this sub-section.

Withdrawal of timber licenses. **"1631f.** With the consent of the licensee, lands under license to cut timber may be withdrawn from such license to form a township forest reserve."

Coming into force. **2.** This act shall come into force on the day of its sanction.

## CHAP. 18

An act to amend the Revised Statutes, 1909, respecting the division of the county of Lake St. John for agricultural purposes.

[Assented to 14th March, 1911]

R.S.Q., 1795, am. **1.** Article 1795 of the Revised Statutes, 1909, as amended by section 1 of the act 1 George V, chapter 13, is further amended by inserting after the word "Beauce" in the third line, the words "Lake St. John."

Coming into force. **2.** This act shall come into force on the day of its sanction.

## CHAP. 19

An Act to amend the Revised Statutes, 1909, respecting farmers' clubs.

[Assented to 14th March, 1911]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

R.S.Q., 1865, am. **1.** Article 1865 of the Revised Statutes, 1909, is amended by adding the following paragraph :

"Nevertheless a club cannot alone hold a fall exhibition such as is ordinarily held by agricultural societies."

**2.** Article 1886 of the said statutes is amended by adding the following paragraph :

"The Council of Agriculture may prescribe the manner in which a farmers' club shall apply its Government grant."

**3.** The following article is inserted in the said statutes after article 1893 :

"**1893a.** 1. In addition to the grant mentioned in article 1893, every farmers' club may receive the following grants payable out of the balance of the appropriation mentioned in article 1855 or out of any other moneys voted for farmers' clubs :

*a* Every club which has had in its possession and kept, for the benefit of its members, one or more registered bulls, for a period of at least nine months during the previous year, or which has given a premium of at least fifty dollars to the proprietor of a registered bull which has been kept for breeding for the benefit of the members of the club, for a period of at least nine months during the previous year, shall receive a grant of fifty dollars ;

Conditions.

*b* Every club which has had in its possession and kept for the benefit of its members, one or more thoroughbred registered boars, for a period of at least nine months during the previous year, or which has given a premium of at least fifteen dollars to the proprietor of a registered boar, which has been kept for breeding, for the benefit of the members of the club, shall receive a grant of fifteen dollars ;

*c.* Every club which has had in its possession and has kept, for the benefit of its members, one or more thoroughbred registered rams for a period of at least nine months during the previous year, or which has given a premium of at least fifteen dollars to the proprietor of a registered ram, which has been kept for breeding purposes, for the benefit of the members of the club, shall receive a premium of fifteen dollars.

2. If the premium is less than the amount mentioned in paragraph 1 of this article, the grant shall be equal to the amount of the premium.

3. The proprietor of the animals on account of which a premium has been given, as mentioned in paragraph 1 of this article, may be a breeding syndicate or a co-operative society.

4. Articles 1894 to 1897 both inclusive, of the Revised Statutes, 1909, shall apply, *mutatis mutandis*, to the grant authorized by this act."
