

school municipality under the jurisdiction and control of the Protestant Board of School Commissioners of the city of Montreal, and the said school trustees for the municipality of Cote Visitation shall cease to exist except for the purpose of winding up their affairs, and all rights, property, debts and obligations of the said school corporation shall vest in and be assumed by the Board of Protestant School Commissioners of the city of Montreal ; provided, however, that nothing in this act shall deprive any person who, at the time of such annexation, was a creditor of the said school corporation, of any right, remedy, privilege or recourse which he would have had or could have exercised if this act had not come into force.

## C H A P . 2 9

An act to authorize the Board of Roman Catholic School Commissioners of Montreal to establish infant schools, and primary superior schools.

[Assented to 24th March, 1911]

**W**HEREAS, the Board of Roman Catholic School Commissioners of Montreal have prayed by their petition, that they be granted the necessary authority to establish infant schools and primary superior schools, and it is expedient to grant the prayer of said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The Board of Roman Catholic School Commissioners of Montreal are hereby authorized to establish infant schools and primary superior schools ; to defray the cost of their establishment and maintenance from the funds at their disposal ; to employ in the said schools, for the purpose of imparting instruction, any competent teacher, though not holding a teacher's diploma for the Province of Quebec ; to fix the school age of the pupils attending said schools, and to allow, under such conditions as the said Board of Commissioners may deem proper, the admission into said primary superior schools of pupils whose parents live outside the territory of the Montreal City School Commissioners ; to determine the subjects to be taught

in said schools, and to make all necessary rules and regulations for their proper working and for their good administration, subject to the approbation of the Roman Catholic Committee of the Council of Public Instruction.

**2.** The power of expropriation mentioned in article 2751 of the Revised Statutes, 1909, may be exercised by the Catholic School Commissioners of Montreal as regards property built upon, as well as vacant property.

## C H A P . 3 0

### An act respecting the Polytechnic School

[Assented to 14th March, 1911]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Section 5 of the act 57 Victoria Chapter 23 is amended by adding the following paragraph :

“The corporation shall also have the right to expropriate any lands and buildings the expropriation of which may be considered necessary for the objects thereof.”

**2.** Section 17 of the said act, as amended by the acts 3 Edward VII, chapter 17, section 4 ; 7 Edward VII, chapter 28, section 1 ; 8 Edward VII, chapter 31, section 1, and 9 Edward VII, chapter 35, section 1, is further amended by replacing the word “twenty” in the fourth line by the words “twenty-five.”
