

C H A P . 3 1

An act to annex the school municipality of La Longue Pointe, in the county of Hochelaga, to the school municipality of the Board of Catholic School Commissioners of Montreal.

[Assented to 24th March, 1911]

WHEREAS, the school commissioners for the municipality of La Longue Pointe, in the county of Hochelaga, have, by their petition, represented that it is in their interest and in that of the Board of Catholic School Commissioners of Montreal, that their school municipality be annexed to that of the said board ; and whereas it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The school municipality of Longue Pointe, in the county of Hochelaga, is annexed to the school municipality under the jurisdiction and control of the Board of Catholic School Commissioners of Montreal. Annexation of school municipality of Longue Pointe to Montreal.

2. From and after the date of the annexation, the Board of Catholic School Commissioners of Montreal, shall be vested with the rights and subject to the obligations of the school commissioners for the municipality of Longue Pointe, in the county of Hochelaga, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said board. Effect of annexation.

3. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 3 2

An Act to amend the act incorporating the Quebec Technical School.

[Assented to 24th March, 1911]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Id., s. 7, am. **3.** Section 7 of the act 7 Edward VII, chapter 24 is amended by replacing the figures \$10,000 in the fifth line by the figures \$30,000.

Coming into force. **4.** This act shall come into force on the day of its sanction.

C H A P . 3 3

An Act to amend the Jury Law of the Province of Quebec, respecting the qualification of jurors in the district of Pontiac.

[Assented to 14th March, 1911]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

C H A P . 3 4

An Act respecting exhibitions of moving pictures.
