

## C H A P . 3 9

An Act to amend the act of this session intituled : “ An Act to amend article 5685 of the Revised Statutes, 1909, and the Municipal Code, respecting bridges.”

[Assented to 24th March, 1911]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The act of this session intituled “ An Act to amend article 5685 of the Revised Statutes, 1909, and the Municipal Code, respecting bridges ”, and being chapter 38 shall come into force on the day of its sanction. 1 Geo. V, (2 session) c. 38. am.

**2.** This act shall come into force on the day of its sanction. Coming into force.

## C H A P . 4 0

An act respecting bakers, and the manufacture of bread, in certain municipalities.

[Assented to 24th March, 1911]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Notwithstanding any law or by-law to the contrary, all bread sold or made for sale within the limits of the Province shall be made of good and wholesome flour and baked in loaves of one, two, three, four, five or six pounds or more, but without any fraction of a pound above the pound ; and the said bread must have one of the weights aforesaid eight hours after having been baked, sold or exposed for sale. How bread to be baked, &c.

**2.** Nevertheless, in cities and towns, any bread may be made and sold by weight, but it shall bear a label of three quarters of an inch square mentioning the exact weight and the baker’s name. Sale of bread in cities and towns.

**3.** Bread weighing not more than twelve ounces and bearing no label may be made in the Province. Bread if not more than 12 ounces &c

- Penalty.      **4.** Every person carrying on the business or industry of a baker contrary to the provisions of this act, is guilty of an offence and is liable for each offence to a fine of not more than twenty dollars, and, in default of payment, to imprisonment of not more than thirty days.
- Procedure.    **5.** Prosecutions taken in pursuance of this act shall be taken, tried and decided in accordance with the provisions of the Municipal Code, except in cities and towns which shall remain subject to the provisions of their respective charters or of the Cities and Towns' Act.
- Coming into force.    **6.** This act shall come into force on the first day of May 1911.

C H A P . 4 1

An Act to amend the Revised Statutes, 1909, respecting electric light and power companies.

[Assented to 24th March, 1911]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

- R.S.Q, 6238a, added.      **1.** The following section and article are inserted in the Revised Statutes, 1909, after section eighth of chapter third of title eleventh.

SECTION VIIIa

“ ELECTRIC LIGHT AND POWER COMPANIES

Application of 6237 to certain companies.      “ **6238a.** The provisions of article 6237, apply *mutatis mutandis*, to incorporated electric light or power companies, or to incorporated electric light and power companies. ”

- Coming into force.      **2.** This act shall come into force on the day of its sanction
