

Quebec Insurance Act to apply.

19. The Quebec Insurance Act shall apply to *La société St. Jean Baptiste de Salaberry* in so far as its provisions respecting mutual benefit societies and charitable associations, are not inconsistent with those hereby enacted.

Statements to L. G. in C.

20. The corporation shall, whenever required by the Provincial Secretary, send to the Lieutenant-Governor in Council, a statement of its moveable and immoveable property, the names of its officers, and a certified copy of its by-laws.

Coming into force.

21. This act shall come into force on the day of its sanction.

C H A P . 9 8

An act to incorporate *La Société du Parler Français au Canada*.

[Assented to 14th March, 1911]

Preamble.

WHEREAS, *Mgr.* Paul Eugène Roy, auxiliary bishop of Quebec with the title of Bishop of Eleutheropolis ; *Mgr.* C. O. Gagnon, P. D. ; *abbé* Amédée Gosselin, rector of Laval University ; Honorable Pierre Boucher de la Bruère, Superintendent of Public Instruction, *abbés* François Pelletier, Stanislas Alfred Lortie and Camille Roy, Messrs Joseph Evariste Prince, advocate ; Eugène Rouillard, civil service officer ; and Adjutor Rivard, advocate, all of Quebec ; Paul de Cazes, of Paris, in France, and Homer Héroux, journalist of Montreal, have by their petition represented :

That they are members constituting the board of management of an association known under the name of "*Société du Parler Français au Canada*." ;

That such association was founded in Quebec on the 18th February, 1902 ; that it has been in existence since then and has a large number of members in the Province of Quebec and elsewhere ;

That its objects are the preservation, extension, defence and cultivation of the French language and of French literature in Canada ;

Whereas, for the purpose of prosecuting such work, the persons above mentioned, have prayed to be incorporated with other members of their association, under the name of "*La Société du Parler Français au Canada*" and whereas it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. *Mgr. Paul Eugène Roy, Mgr. C. O. Gagnon, abbé Amé- Persons in-
dée Gosselin, Honorable Pierre Boucher de la Bruère, abbés* incorporated.
François Pelletier, Stanislas Alfred Lortie and Camille Roy, Messrs Joseph Evariste Prince, Eugène Rouillard, Adjutor Rivard, Paul de Cazes, Homer Héroux and all other persons who are now or may become members of the association are incorporated under the name of "La Société du Parler Name. Français au Canada."

2. The corporate seat of the corporation shall be in the *Corporate
city of Quebec.* seat.

3. The object of the corporation is the preservation, ex-Objects.
tension, defence and cultivation of the French language and of French literature in Canada and its means of action are : the study and teaching of French generally and especially of French spoken in Canada in its sources, history, features, its legal position and its conditions of existence ; the establishment, organization and direction of associations for study, clubs, courses, conferences and congresses ; putting into practice of suitable methods for diffusing the taste for and the cultivation of the French language, both written and spoken, in Canada, for defending it against the dangers that threaten it, for assuring its preservation and of promoting its extension ; development of sound criticism and of a national literature in French Canada ; encouragement of French Canadian literature ; the organization of competitions, founding of prizes, giving of rewards, awarding diplomas and certificates ; propagandism by word of mouth and by writings ; the publication of works, bulletins and periodicals and generally such works and undertakings as may aid the corporation in attaining its ends.

The corporation shall have perpetual succession and may : Powers.

Have a common seal and change the same at will ;

Appear before the courts ;

Acquire and receive by purchase, gift, will, legacy or otherwise and hold, moveable and immoveable property ; collect the revenue therefrom ; lease, sell, exchange, transfer, alienate or otherwise dispose of the same ; borrow and contract obligations ; and hypothecate immoveables, provided the value of the immoveables held at any time by the corporation shall not exceed one hundred thousand dollars ;

Collect assessments and subscriptions from its members ;

Organize and direct associations for study, clubs, inquiries, courses, conferences and congresses in the prosecution of its object ;

Establish committees, clubs, offices and agencies of the corporation in the Province of Quebec ;

To affiliate similar societies, associations or corporations with it and represent them in Canada ; also to affiliate itself with any society, institution, academy, university or corporation with which it may deem it expedient to affiliate ;

Encourage studies and works in connection with philology, dialectology, linguistics, French grammar and literature ; for such purpose, organize competitions, found prizes, give rewards, award diplomas and certificates ; aid and maintain, in accordance with their needs and the resources of the corporation, undertakings of a nature to spread the taste for and the cultivation of the French language, both written and spoken in Canada ;

Found and maintain libraries and reading rooms ;

Publish works, bulletins, periodicals and sheets suited to its designs and objects for the carrying on of its propagandism ;

And, generally have all the powers vested in ordinary civil corporations with such powers as may help it to attain its end or serve for the carrying out of its means of action and the execution of its undertakings.

Present by-laws.
Powers as to by-laws.

5. The present by-laws of the association not contrary to law, shall be the by-laws of the corporation until changed or repealed ; and the corporation may adopt such by-laws, ordinances, rules and proceedings, not contrary to law, as it may deem advisable, and modify, amend or repeal the same in connection with the following :

The organization, management and government of the corporation and its various branches ;

The management and administration of its affairs and property ;

The constitution, organization, powers, working and government of its board of directors, committees, clubs and agency ; the number, selection, appointment, dismissal, and replacing of its members ;

The number, selection, appointment, dismissal, duties and remuneration of its officers, agents, servants and employees ;

The qualification, classification, admission, rights, dismissal expulsion and assessments of its members ;

The conditions for affiliation and the privileges and obligations of affiliated associations ;

The employment of the moneys, the creation and collection of the corporation's revenues ;

The adoption, amendment, putting into force and repeal of the by-laws, ordinances, rules, and resolutions of the corporation and of its boards and committees ;

And generally everything connected with the objects of

the corporation, its organization, government, working, administration, the carrying out of its means of action and the exercise of its powers.

The powers conferred on the corporation by this section may be exercised by the general meeting of its members or by a committee, board or council, as may be determined by the by-laws themselves.

And the affairs, works and undertakings of the corporation shall be administered according to such by-laws, ordinances, rules and resolutions.

6. The present officers of the association shall continue ^{Present officers.} to perform the duties and exercise the rights of their offices until replaced in accordance with the corporation by-laws.

By the coming into force of this act the corporation shall ^{Rights acquired.} be vested with the property and rights now held by *La Société du Parler Français au Canada*.

7. The corporation shall, whenever required by the Provincial Secretary, send to the Lieutenant-Governor-in-Council ^{L. G. in C.} a statement of its moveable and immoveable property, the names of its officers and a certified copy of its by-laws.

8. This act shall come into force on the day of its sanction. ^{Coming into force.}

C H A P . 9 9

An act to incorporate *La Ligue Antituberculeuse des Trois-Rivières*

[Assented to 24th March, 1911]

WHEREAS, Honorable. François Siméon Tourigny, judge of the Superior Court ; Louis Philippe Normand, physician ; Georges Bourgeois, physician ; Philippe L. Lassonde ; Charles R. Whitehead, manufacturer ; Auguste Desilets, advocate ; and Joseph Adolphe Tessier, advocate, K.C., member of the Legislative Assembly, have, by their petition, represented that they have decided to establish an association against tuberculosis and against its progress and have for such purpose prayed to be incorporated under the name of "*La Ligue antituberculeuse des Trois-Rivières*." ; and

Whereas such an association would be one of public utility, and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
