

the corporation, its organization, government, working, administration, the carrying out of its means of action and the exercise of its powers.

The powers conferred on the corporation by this section may be exercised by the general meeting of its members or by a committee, board or council, as may be determined by the by-laws themselves.

And the affairs, works and undertakings of the corporation shall be administered according to such by-laws, ordinances, rules and resolutions.

6. The present officers of the association shall continue ^{Present officers.} to perform the duties and exercise the rights of their offices until replaced in accordance with the corporation by-laws.

By the coming into force of this act the corporation shall ^{Rights acquired.} be vested with the property and rights now held by *La Société du Parler Français au Canada*.

7. The corporation shall, whenever required by the ^{Pro-Statement to} vincial Secretary, send to the Lieutenant-Governor-in-Council ^{L. G. in C.} a statement of its moveable and immoveable property, the names of its officers and a certified copy of its by-laws.

8. This act shall come into force on the day of its sanction. ^{Coming into force.}

C H A P . 9 9

An act to incorporate *La Ligue Antituberculeuse des Trois-Rivières*

[Assented to 24th March, 1911]

WHEREAS, Honorable. François Siméon Tourigny, judge of Preamble.
the Superior Court ; Louis Philippe Normand, physician ; Georges Bourgeois, physician ; Philippe L. Lassonde ; Charles R. Whitehead, manufacturer ; Auguste Desilets, advocate ; and Joseph Adolphe Tessier, advocate, K.C., member of the Legislative Assembly, have, by their petition, represented that they have decided to establish an association against tuberculosis and against its progress and have for such purpose prayed to be incorporated under the name of "*La Ligue antituberculeuse des Trois-Rivières*." ; and

Whereas such an association would be one of public utility, and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

- Persons incorporated.** **1.** The persons above mentioned, together with all others who may join them and become members of the association under such by-laws as it may make, are incorporated under the name of "*La Ligue antituberculeuse des Trois-Rivières*," hereinafter called "*The League*," for the objects mentioned in the preamble.
- Name.** The name of "*La Ligue antituberculeuse des Trois-Rivières*," hereinafter called "*The League*," for the objects mentioned in the preamble.
- Corporate seat, &c.** **2.** The corporate seat of the league shall be in the city of Three Rivers, and it may exercise its powers within the territory of the judicial district of Three Rivers.
- Powers.** **3.** The league shall have all the powers and rights which belong to civil and commercial corporations, including that of holding, acquiring, hypothecating and alienating immovables, the value whereof shall not exceed twenty thousand dollars.
- Means of action.** **4.** The means of action of the league shall be :
 1. The diffusion among the masses of useful knowledge for preventing and contending against tuberculosis ;
 2. The establishment, organization and maintenance of all necessary or useful works and buildings for carrying out the object of the league.
- Composition.** **5.** The league may consist :
 a. Of a central section ;
 b. Of local sections ;
 c. Of affiliated or associated sections ;
 d. Of isolated members.
- Central section.** **6.** The seat of the central section shall be in the city of Three Rivers at the corporate seat of the league whereof it shall be the nucleus ; it shall pass by-laws, establish the amount of the contributions and adopt regulations for its internal government, as well as those it may deem advisable to apply to the local sections and affiliated or associated societies. Its officers shall be those of the general council.
- Local sections.** **7.** The local sections shall be under the direction of the central section in accordance with such by-laws as the latter may adopt.
- Isolated members, &c.** **8.** Every person approved by the general council may have himself inscribed directly at the central section as an isolated member ; every person belonging to an antituberculosis society shall be *ex officio* a member of the league on condition that he applies therefor.

9. The society shall be managed by a general council ^{General} composed of such persons as may be determined by the by- ^{council.} laws the league may deem expedient to adopt.

10. The members of the council shall be appointed by ^{Appointment} the general meeting of the members of the league, to be held ^{of general} annually and it may also elect honorary officers. ^{council.}

11. The resources of the league shall consist of the pro- ^{Resources of} ceeds of : ^{league.}

1. The annual contributions ;
2. All gifts and legacies made to it and which it is authorized to accept ;
3. The receipts of all kinds which may be realized.

12. The council may make all by-laws necessary for the ^{By-laws.} attainment of the object the league has in view.

13. The corporation shall transmit to the Lieutenant- ^{Statement to} Governor in Council, whenever thereunto required by the ^{L. G. in C.} Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and by-laws.

14. The members shall not be personally liable for any ^{Members not} of the debts or obligations of the league. ^{liable for} debts.

15. This act shall come into force on the day of its sanction. ^{Coming into} force.

An Act to amend the Act 56 Victoria, chapter 86, respecting
Les Religieuses de l'Hôtel-Dieu de Lévis.

[Assented to 24th March, 1911]

WHEREAS *Les Religieuses de l'Hôtel-Dieu de Lévis* have, Preamble.
by their petition represented :

That for the better administration of their affairs, it is necessary that their charter, the act 56 Victoria, chapter 86, be amended, and that their corporation be substituted to *Le bien des pauvres de l'Hôtel-Dieu de Lévis* ;

That His Grace the Archbishop of Quebec has no objection to the same ;
