2. All gifts and legacies made to it and which it is authorized to accept ;
3. The receipts of all kinds which may be realized.

12. The council may make all by-laws necessary for the ^{By-laws.} attainment of the object the league has in view.

13. The corporation shall transmit to the Lieutenant- ^{Statement to} Governor in Council, whenever thereunto required by the ^{L. G. in C.} Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and by-laws.

14. The members shall not be personally liable for any ^{Members not} of the debts or obligations of the league. ^{liable for} debts.

15. This act shall come into force on the day of its sanction. ^{Coming into} force.

C H A P . 1 0 0

An Act to amend the Act 56 Victoria, chapter 86, respecting
Les Religieuses de l'Hôtel-Dieu de Lévis.

[Assented to 24th March, 1911]

WHEREAS *Les Religieuses de l'Hôtel-Dieu de Lévis* have, Preamble.
by their petition represented :

That for the better administration of their affairs, it is necessary that their charter, the act 56 Victoria, chapter 86, be amended, and that their corporation be substituted to *Le bien des pauvres de l'Hôtel-Dieu de Lévis* ;

That His Grace the Archbishop of Quebec has no objection to the same ;

And whereas no objection has been made by the interested parties and it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

56 V., c. 86, s. 2, replaced. **1.** Section 2 of the act 56 Victoria, chapter 86, is replaced by the following :

Powers of corporation.

" 2. The corporation shall have perpetual succession and a common seal, and may, for the purposes and requirements of its undertakings, acquire, hold, possess and receive all property of any kind whatsoever, by gift, legacy, purchase, exchange or otherwise ; alienate the same, and acquire others instead, by any legal title whatsoever ; borrow, hypothecate and perform any act as proprietors, provided that the annual value of such real estate shall not exceed the sum of twenty thousand dollars, not including the buildings required for the said corporation with the land on which they are or may be erected.

Signing of deeds.

Every such deed signed by the Sister Superior and the councillors, but with the consent and authority of the chapter of the said community, as to the acquisition and alienation of real estate, shall be valid for all lawful purposes."

Id., s. 5 replaced.

2. Section 5 of the said act is replaced by the following :

Property of corporation.

" 5. All the moveable and immoveable property possessed by *Le bien des pauvres de l'Hôtel-Dieu de Lévis* or belonging to it, are and shall become the property of *Les Religieuses de l'Hôtel-Dieu de Lévis*.

Rights, &c., of corporation.

Les Religieuses de l'Hôtel-Dieu de Lévis are vested with all rights and actions which the *Le bien des pauvres de l'Hôtel-Dieu de Lévis* can exercise, and all legacies, gifts, or transfers contained in the donations, wills or transfers, made in favor of the latter shall enure to the *Les religieuses de l'Hôtel-Dieu de Lévis*.

Obligations, &c., of corporation.

Les religieuses de l'Hôtel-Dieu de Lévis assume all the obligations and responsibilities of *Le bien des pauvres de l'Hôtel-Dieu de Lévis*.

Vesting of rights, &c.

Such transfer of all the moveable and immoveable property, rights, actions or obligations of *Le bien des pauvres de l'Hôtel-Dieu de Lévis* to the *Les religieuses de l'Hôtel-Dieu de Lévis* shall have effect fully and without intermission and *Les religieuses de l'Hôtel-Dieu de Lévis* shall be seized and vested therewith as fully as if they always had the possession and ownership of the same."

Statements to L. G. in C.

3. The corporation shall, whenever required by the Provincial Secretary, send to the Lieutenant-Governor in Council a

statement of its moveable and immoveable property, the names of its officers and a certified copy of its by-laws.

4. Section 6 of the said act is repealed.

CHAP. 101

An act to incorporate The District of Bedford General Hospital.

[Assented to 24th March, 1911]

WHEREAS, the persons hereinafter named, and others, Preamble.

by their petition have alleged and shown that a subscription has been set on foot to provide funds for the founding and erecting of an hospital in the village of Sweetsburg, to be known as "The District of Bedford General Hospital", and a parcel of land has been acquired for that purpose, and contributions and donations have already been subscribed, and that others may be expected in furtherance of said object ; and whereas the said hereinafter named persons and others have prayed that they may be incorporated for the purposes of this act ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Claude O. Robb, of the township of Dunham, John F. Yeats, of the village of Dunham, George F. L. Fuller and George W. Johnston, of the village of Cowansville, Lewis C. Parsons, Follin H. Pickel, Crawford M. Beattie, F. X. Arthur Giroux, George H. Boivin, all of the village of Sweetburg, Esquires, and all such persons who shall hereafter contribute to the institution hereby created, either by a donation respectively of at least two hundred and fifty dollars, or who shall sign the constitution and regularly continue to pay annually towards its support not less than five dollars each, and their successors, are hereby created a body politic and corporate at the village of Sweetsburg, in the district of Bedford, in the Province of Quebec, under the name of "The District of Bedford General Hospital".

Persons incorporated.
