An Act to incorporate "The Hebrew Sheltering Home."

[Assented to 24th March, 1911]

WHEREAS Morris B. Steine, merchant, Louis Holstein, Preamble.
 steamship-broker, Moses L. Morris, merchant, David Sperber, merchant, Mortimer B. Davis, manufacturer, Ascher Pierce, merchant, Jacob A. Jacobs, capitalist, Mark Workman, merchant, Moses Vineberg, manufacturer, Harris Vineberg, manufacturer, Isaac Goldberg, merchant, Joseph Steinberg, merchant, Philip Popliger, merchant, and Henry Bye, commercial traveller, all of the city and district of Montreal, have by petition set forth that a Jewish charitable institution to be used as an asylum or home for the aged, destitute, strangers and others, and also for the purpose of establishing a home for children who may be deprived of their natural protectors either by death or abandonment or otherwise, belonging to the Hebrew faith, and for the purpose of protecting such persons and children, is at the present time urgently needed in the city of Montreal, and that they are persons professing the Jewish religion and have prayed to be incorporated as a body politic and corporate under the name of "The Hebrew Sheltering Home"; and whereas it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Name.

Certain property vested in corporation, &c. **2.** All property moveable and immoveable now possessed or held in trust for the said corporation shall be and is hereby transferred to and vested in the said corporation and the said corporation shall have, hold and exercise all rights belonging to the said corporation and shall be subject to all liabilities and obligations contracted by it.

General powers of corporation. **3.** The said corporation may under that name possess a common seal with power to alter, change and renew the same and have perpetual succession, and shall have all rights incidental to corporations generally and all the powers hereby granted.

Acquisition, &c., of property, &c. **4.** The said corporation may at all times acquire, sell, transfer, lease, exchange, hypothecate, and alienate its immoveable property and the said corporation shall have the power to make, draw, accept, endorse and transfer bills of exchange, promissory notes, cheques, bonds and other negotiable documents and instruments under the signature of its officers and others in its corporate name as shall be determined by the by-laws of the said corporation.

Acquisition, &c., of immoveable property, &c. **5.** The said corporation may have, hold, sell, possess, erect and acquire by gift, purchase, will or otherwise any immoveable property in and near the city of Montreal that may be required and may acquire, lease, erect, alter or exchange suitable buildings and maintain, alter or renew the same as may be required for its purposes and for the proper carrying out of the objects of the corporation, provided always that the annual value of the immoveable property held by the said corporation shall not exceed the sum of twenty thousand dollars.

Disposing of surplus immoveables. **6.** In the event of the said corporation acquiring or receiving by gift or will or otherwise any immoveable property in excess of that which it is hereby authorized to possess the said gift or legacy or other acquisition shall not on that account be void, but the said corporation shall be bound within five years from the date of its entering into peaceable possession of the said gift or legacy or acquisition, to sell, and dispose of the said immoveable property or part of it or some other of its immoveable property or part of it in such a manner that the immoveable property of the said corporation shall not exceed in annual value the sum of twenty thousand dollars.

By-laws, &c. **7.** The said corporation shall be authorized to make by-laws, rules and regulations for its internal government and

for the government and discipline of its officers and members and for the supervision of its affairs, such officers to be elected as may be provided for by the said by-laws, rules and regulations and the mode, time, election, number and qualifications of its officers to be also determined by the said by-laws, rules and regulations, and to amend or repeal the said by-laws, rules and regulations, provided always that none of the said by-laws, rules and regulations be inconsistent with this act or with the laws of this Province.

8. The said corporation acting through its officers shall also be authorized to make and establish such rules and regulations as shall be deemed necessary or useful for the management, regulation and control of the said institution, and for the management, regulation and control of its agents, employees and servants, and for the appointment or removal of its agents, employees and servants and their wages or allowances, and also to make and establish rules and regulations for the admission, care and discharge and discipline of its inmates, and to amend or repeal the said rules and regulations and to exercise such powers as may be necessary for the proper control and government of the said institution, provided always that nothing in the said rules and regulations be inconsistent with this act or with the laws of this Province.

9. The said corporation shall have the power to collect and enforce by suit at law or other legal proceedings the payment of all subscriptions, donations, membership dues and other fees or instalments on the same.

10. All and every the funds and property of the said corporation shall be appropriated and applied solely for the purposes of the said corporation and the payment of all such outlays and expenditures as may legitimately be incurred in connection therewith, and for the proper carrying out of the objects contemplated.

11. None of the officers or members of the said corporation shall be liable or responsible for the debts of the said corporation.

12. Nothing in this act shall prevent the provisions of the charter of the city of Montreal or of the by-laws passed by the said city in accordance with its charter from applying to the provisions of this corporation, nor the provisions of the law governing public health.

CHAP. 108

An act to incorporate *Les Dominicaines du Rosaire*

[Assented to 24th March, 1911]

Preamble.

WHEREAS, Rosa Anna Gariépy, in religion Sister Hyacinthe du Sacré-Cœur; Odélie Hardy, in religion Sister Rose de Lima; Emma Champagne, in religion Sister Marie Dominique, all of the city and district of Three Rivers, and at present members of the community, called "*Les Dominicaines du Rosaire*", have, by their petition, prayed to be incorporated under the name of "*Les Dominicaines du Rosaire*," for the following among other objects : to devote themselves in common to the household work of the diocesan seminary and of the Brothers' schools, to the care of young girls, boarders, old people, sick and infirm persons either in their homes or in the hospitals, and all works in connection with orphans, with power to establish novitiates, houses and other establishments in the Province of Quebec, and for such purpose to acquire moveable and immoveable property and generally to manage and administer their affairs under such corporate name ;

And whereas it is expedient to incorporate them ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

Persons incorporated.

1. Rosa Anna Gariépy, in religion Sister Hyacinthe du Sacré Cœur; Odélie Hardy, in religion Sister Rose de Lima ; Emma Champagne, in religion Sister Marie Dominique, all of the city of Three Rivers in the district of Three Rivers and at present members of the community called "*Les Dominicaines du Rosaire*," and all such persons as do now or shall hereafter form part of the said community in accordance with its rules, by-laws and regulations, are incorporated under the name of "*Les Dominicaines du Rosaire*," which community shall be under the direction of the bishop of the diocese of Three Rivers.
