## CHAP. 108

An act to incorporate *Les Dominicaines du Rosaire*

[Assented to 24th March, 1911]

Preamble.

**W**HEREAS, Rosa Anna Gariépy, in religion Sister Hyacinthe du Sacré-Cœur; Odélie Hardy, in religion Sister Rose de Lima; Emma Champagne, in religion Sister Marie Dominique, all of the city and district of Three Rivers, and at present members of the community, called "*Les Dominicaines du Rosaire*", have, by their petition, prayed to be incorporated under the name of "*Les Dominicaines du Rosaire*," for the following among other objects : to devote themselves in common to the household work of the diocesan seminary and of the Brothers' schools, to the care of young girls, boarders, old people, sick and infirm persons either in their homes or in the hospitals, and all works in connection with orphans, with power to establish novitiates, houses and other establishments in the Province of Quebec, and for such purpose to acquire moveable and immoveable property and generally to manage and administer their affairs under such corporate name ;

And whereas it is expedient to incorporate them ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

1. Rosa Anna Gariépy, in religion Sister Hyacinthe du Sacré Cœur; Odélie Hardy, in religion Sister Rose de Lima ; Emma Champagne, in religion Sister Marie Dominique, all of the city of Three Rivers in the district of Three Rivers and at present members of the community called "*Les Dominicaines du Rosaire*," and all such persons as do now or shall hereafter form part of the said community in accordance with its rules, by-laws and regulations, are incorporated under the name of "*Les Dominicaines du Rosaire*," which community shall be under the direction of the bishop of the diocese of Three Rivers.

Name.

**2.** The corporation hereby constituted shall have per-Powers. petual succession and may have a common seal with power to change the same at will. It may appear before the courts as any other persons may do, borrow, sign bills of exchange and promissory notes, hold, accept and acquire moveable and immoveable property by any legal title and lease, sell, exchange, transfer or otherwise alienate all its moveable and immoveable property by any title and hypothecate its immoveables ; but the value of the immoveables held by the said community shall not exceed the sum of five hundred thousand dollars according to the valuation roll, and the revenue therefrom shall be used for the purposes of the corporation; the whole, under the direction and with the approval of the bishop of the diocese of Three Rivers.

**3.** The corporate seat of the corporation shall be in the city Corporate of Three Rivers, but it may be changed by the corporation seat, &c. with the approval of the diocesan bishop, if he deem the same necessary, upon the corporation giving notice for six months in the *Quebec Official Gazette* and in a French and in an English newspaper published in that district or if there be no such French or English newspaper published in that district then in a French or English newspaper published in the district or in a neighbouring one.

**4.** The corporation shall be governed by the rules of the Government community and it may adopt by-laws or rules which it may afterwards amend or repeal, respecting the administration of its property ; the direction and government of its houses or establishments ; the election, number and powers of its directresses and officers ; the attributes of each of its members, their admission and removal and generally adopt all by-laws not contrary to the laws of the community connected with the purposes of the corporation, the whole under the direction and with the approval of the bishop of Three Rivers whose decision shall be final.

**5.** The corporation may found, establish and maintain Founding, novitiates, convents, establishments, branches and other houses &c., of novitiates, &c. at any place in this Province and erect such buildings as may be suitable for its purposes in every place where it may have an establishment, and have cemeteries in connection with such convents, but the establishment of all cemeteries shall be subject to the authorizations and formalities required by law and on condition that, in any city or town, bodies may be buried in an underground chapel by complying with the health laws and regulations and with the approval of the bishop of the diocese of Three Rivers.

**Appointment of officers, &c.** **6.** The corporation may appoint officers, procurators or administrators from among its members and define their powers ; it may also appoint one or more procurators outside the community who can transact and conclude business only with the approval of the bishop of the diocese of Three Rivers.

**Signing of documents.** Every document bearing the signature of the chief superior-residing at the corporate seat and that of the members of the council or signed by a person with a general authorization under a resolution of the council of the community, shall bind the corporation.

**Statement to L. G. in C.** **7.** The corporation shall, whenever thereunto required by the Lieutenant-Governor in Council, transmit a statement of the immoveables held by it under this act and a copy of the rules and regulations of the community.

**Coming into force.** **8.** This act shall come into force on the day of its sanction.

## C H A P . 1 0 9

An Act to amend the act 63 Victoria, chapter 94, respecting the parish of St. Denis, Montréal.

*[Assented to 24th March, 1911]*

**Preamble.** **W**HEREAS a petition has been presented by the Reverend J. A. St-Jean, parish priest ; Clovis Boucher, quarryman ; Magloire Gagnon, grocer ; Elie Prénoveau, quarryman and David Dépatie, burgess, of the city of Montreal, for the passing of an act to amend the act 63 Victoria, chapter 94, to aid the completion of the church and rectory of the parish of St. Denis, Montréal ;

And whereas it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**63 V., c. 94, s. 2a, added.** **1.** The following section is added after section 2 of the act 63 Victoria, chapter 94 :

**Additional levy.** **"2a.** The said trustees may levy annually by means of the act of assessment mentioned in section 1, in addition to the amount required to pay the interest and sinking fund on the loan aforesaid and the costs of the apportionment, such additional amount as they may deem expedient, provided the total yearly apportionment shall not exceed twenty cents per
