

Appointment of officers, &c. **6.** The corporation may appoint officers, procurators or administrators from among its members and define their powers ; it may also appoint one or more procurators outside the community who can transact and conclude business only with the approval of the bishop of the diocese of Three Rivers.

Signing of documents. Every document bearing the signature of the chief superior-residing at the corporate seat and that of the members of the council or signed by a person with a general authorization under a resolution of the council of the community, shall bind the corporation.

Statement to L. G. in C. **7.** The corporation shall, whenever thereunto required by the Lieutenant-Governor in Council, transmit a statement of the immoveables held by it under this act and a copy of the rules and regulations of the community.

Coming into force. **8.** This act shall come into force on the day of its sanction.

C H A P . 1 0 9

An Act to amend the act 63 Victoria, chapter 94, respecting the parish of St. Denis, Montréal.

[Assented to 24th March, 1911]

Preamble. **W**HEREAS a petition has been presented by the Reverend J. A. St-Jean, parish priest ; Clovis Boucher, quarryman ; Magloire Gagnon, grocer ; Elie Prénoveau, quarryman and David Dépatie, burgess, of the city of Montreal, for the passing of an act to amend the act 63 Victoria, chapter 94, to aid the completion of the church and rectory of the parish of St. Denis, Montréal ;

And whereas it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

63 V., c. 94, s. 2a, added. **1.** The following section is added after section 2 of the act 63 Victoria, chapter 94 :

Additional levy.

“ 2a. The said trustees may levy annually by means of the act of assessment mentioned in section 1, in addition to the amount required to pay the interest and sinking fund on the loan aforesaid and the costs of the apportionment, such additional amount as they may deem expedient, provided the total yearly apportionment shall not exceed twenty cents per

one hundred dollars of the value of the property taxed, and they may hand over the surplus so levied to the *fabrique* of the parish of St. Denis, Montréal, to aid it to complete the building of the church and rectory of the said parish."

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 1 0

An act to amend the act respecting the parish of *Saint-Enfant Jésus*, de Montreal.

[Assented to 24th March, 1911]

WHEREAS the trustees of the parish of *Saint-Enfant Jésus*, of Montreal, have by their petition, represented, Preamble.
that it is urgent that the act 62 Victoria, chapter 91 be amended for the purpose of changing the date of the collection and the date of payment of the church assessments in consequence of the annexation of the town of St. Louis to the city of Montreal ;

Whereas it is expedient to grant the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Sections 2 and 3 of the act 62 Victoria, chapter 91, are replaced by the following : 62 V., c. 91,
ss. 2, 3, re-
placed.

" 2. The amount to be levied every year shall be exigible and payable in annual and consecutive payments; that for 1910-1911, thirty days after the passing of the present act and those for subsequent years, on the first of January of each year. A discount of three per cent shall be allowed on payments effected within fifteen days from the date of their becoming due, and interest at the rate of six per cent shall be charged on payments not effected within thirty days from their becoming due. " 3. The said act of assessment shall be based on the municipal assessment roll in force on the first of December preceding the date at which each of such payments shall become due, and shall not be subject to homologation by the trustees appointed and acting under the Revised Statutes ; and the homologation of the municipal valuation roll shall take the place of such homologation by such trustees." Basis of as-
sessment.

4. This act shall come into force on the day of its sanction. Coming into force.
