

## C H A P . 1 1 3

An act to amend the act respecting the building of the church, sacristy and rectory of the parish of St. Viateur d'Outremont.

[Assented to 24th March, 1911]

**W**HEREAS, the parish priest and churchwardens of *L'Oeu- Preamble.*  
*vre et Fabrique* of the parish of St. Viateur d'Outremont have, by their petition, represented :

That by the act 1 George V, chapter 105 the said *fabrique* of the parish of St. Viateur d'Outremont was authorized to levy from the freehold inhabitants the sum of one hundred thousand dollars to provide for the building of a church, sacristy and rectory ;

That the amount of one hundred thousand dollars is insufficient, and it prays that the said act 1 George V, chapter 105 be amended in such manner as to authorize it to levy one hundred and twenty-five thousand dollars instead of one hundred thousand dollars ;

Whereas the freehold inhabitants have authorized the said petition and it is expedient to grant the prayer it contains ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Section 1 of the act 1 George V, chapter 105, is replaced 1 Geo. V., c.  
by the following : 105, s. 1, re-  
placed.

“ 1. The churchwardens of the parish of St. Viateur d'Outremont in the district of Montreal, may levy by an act of assessment upon all the immoveables of the parish belonging to Roman Catholics, a yearly amount not exceeding twenty cents per one hundred dollars of the value of the property assessed, during a period not exceeding forty years, to be applied to the payment of the interest and sinking fund of a loan of not more than one hundred and twenty-five thousand dollars to be expended in building the church, sacristy and rectory, the cost of the said assessment, that of the ground on which such buildings will be erected and that of this act; provided that the immoveables of the said freehold inhabitants in the said parish shall be affected and the said freehold inhabitants shall be liable only to the amount of the payments due on the said assessments ; and such assessment may be decreased proportionately to the increase of the property assessed. ”

2. For the execution of the work of construction, and upon Loans.  
the security of the assessment, the board of churchwardens is authorized to contract loans, and for such purpose, to effect

such loans by contract, by debentures with or without annuities, or on mortgage, as may be found preferable, provided that the total sum thus borrowed does not exceed one hundred and twenty-five thousand dollars.

placed. **3.** Section 11 of the act 1 George V, chapter 105, is replaced by the following :

ens. “ **11.** The board of churchwardens is authorized to contract, on the security of the said assessment, such loans as they may deem necessary for the erection of the said buildings, provided the total amount so borrowed shall not exceed one hundred and twenty-five thousand dollars. ”

Coming into  
force. **4.** This act shall come into force on the day of its sanction.

#### C H A P . 1 1 4

An act respecting the building of the church and sacristy of the parish of St. Gabriel de Brandon

[Assented to 24th March, 1911]

Preamble. **W**HEREAS, the trustees of the parish of St. Gabriel de Brandon, have, by their petition, represented :

That, since the sanction of the act 9 Edward VII, chapter 138, they have proceeded to the construction of a new church and sacristy in the parish of St. Gabriel de Brandon and that the said buildings are nearly finished ;

That the said buildings have cost much more than had been at first foreseen and, instead of a loan of forty-five thousand dollars they will be obliged to effect one of forty-eight thousand dollars ;

That the securities given for the purpose of contracting such loan have been deemed insufficient by the persons to whom they applied for such loan and that it is necessary that the *curé* and church-wardens of *l'œuvre et fabrique* of the parish of St. Gabriel de Brandon, guarantee such loan ;

That the free-hold inhabitants of the said parish have consented that such guarantee be given and that the resolution adopted by the said free-hold inhabitants was confirmed by His Lordship Joseph Alfred Archambault, bishop of Joliette ;

And whereas the petitioners pray for an act to amend that passed as aforesaid, and whereas it is expedient to grant the prayer to that effect contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the
