C H A P . 1 1 4

An act respecting the building of the church and sacristy of
the parish of St. Gabriel de Brandon

[Assented to 24th March, 1911]

Preamble. **W**HEREAS, the trustees of the parish of St. Gabriel de Brandon, have, by their petition, represented :

That, since the sanction of the act 9 Edward VII, chapter 138, they have proceeded to the construction of a new church and sacristy in the parish of St. Gabriel de Brandon and that the said buildings are nearly finished ;

That the said buildings have cost much more than had been at first foreseen and, instead of a loan of forty-five thousand dollars they will be obliged to effect one of forty-eight thousand dollars ;

That the securities given for the purpose of contracting such loan have been deemed insufficient by the persons to whom they applied for such loan and that it is necessary that the *curé* and church-wardens of *l'œuvre et fabrique* of the parish of St. Gabriel de Brandon, guarantee such loan ;

That the free-hold inhabitants of the said parish have consented that such guarantee be given and that the resolution adopted by the said free-hold inhabitants was confirmed by His Lordship Joseph Alfred Archambault, bishop of Joliette ;

And whereas the petitioners pray for an act to amend that passed as aforesaid, and whereas it is expedient to grant the prayer to that effect contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the

Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Section 3 of the act 9 Edward VII, chapter 138, is replaced by the following :

“ **3.** To meet the cost of the said buildings over and above the twenty-five thousand dollars which the *fabrique* of the parish of St. Gabriel de Brandon has undertaken to furnish, the trustees may borrow, on the security of the assessments to be levied under this act, an amount not exceeding forty-eight thousand dollars, as principal, in such manner and form as they may deem expedient and on such conditions as they may deem advantageous. The trustees shall constitute a corporation under the name of “ *Les Syndics de la paroisse de St. Gabriel de Brandon.* ”

Borrowing for certain purpose.

2. Paragraph 2 of section 6 of the said act is replaced by the following :—

“ **2.** In the seigniorship of Lanaudière, the cadastral numbers 87, 88, 89, 90, 91, 92, 93a, 93b, 93c, 93d, 93e, 93m, 93n, 93o, 93p and 93q inclusive, and bounded as follows : by the Mastigouche river, by part of number 93i, by the numbers 93j, 93k and 93l, the St. Pierre concession, the township of Peterborough and the territory detached from St. Didace ; the other immovables of the said parish of St. Gabriel de Brandon annexed to the parish of St. Charles de Mandeville by the act 7 Edward VII, chapter 9, section 2 are also exempt.”

Exemptions.

3. The following section is inserted in the said act after section 17 :

“ **17a.** The *curé* and churchwardens of *l'œuvre et fabrique* of the parish of St. Gabriel de Brandon are authorized to guarantee the loan to be so effected by the said trustees, either by intervening in the deed of obligation which may be consented to by the latter, either by endorsing the bonds or debentures to be issued by the said trustees in the manner indicated in this act, and the *curé* and churchwardens of *l'œuvre et fabrique* of the parish of St. Gabriel de Brandon, shall be jointly and severally responsible with the said trustees for the repayment of the said loan and accessories.”

Guarantee of certain loan.

4. This act shall come into force on the day of its sanction.
