

## C H A P . 1 4 3

An act to authorize the Board of Notaries of the Province of Quebec to admit Francis Mackay to the practice of the Notarial profession after examination.

[Assented to 14th March, 1911]

## Preamble.

**W**HEREAS, Francis Mackay, notarial student of the city of Montreal has, by his petition represented :

That he has completed a classical and scientific course at St. Mary's College, Montreal ;

That for important reasons it was impossible for him to be admitted to the study of the notarial profession by the Board of notaries at its session of July, 1908 ;

That he was admitted to the study of the notarial profession by the Board of Notaries of the Province of Quebec on 14th July, 1910,

That notwithstanding that he was only admitted to the study of the notarial profession on 14th July, 1910, he regularly and without interruption attended as a notarial student, the office of F. S. Mackay, notary at Montreal from 14th July, 1908, as though he had been under indenture up to 15th July, 1910 ;

That on the 15th July, 1910, he become indentured to F. S. Mackay notary, at Montreal, by deed passed before Mr. Victor Morin, notary, and that since that date he has always attended and still attends the office of his patron as notarial student ;

That he has attended the lectures of the law faculty of Laval University, in Montreal, from September 1908 up to this date and that he purposes to continue attending said lectures until he obtains the degree of Bachelor of Law ;

That he is desirous of passing his examination for the admission to practise the notarial profession at the meeting of the Board of Notaries to be held in July 1911 or any subsequent meeting by producing the certificates and degrees required by law ;

That the said Board of Notaries has consented by resolution passed at its meeting held on 15th July, 1910, that an act should be passed for the purposes of regularizing the clerkship and having it count from the 14th July, 1908 ;

Whereas, the said Francis Mackay has prayed for the passing of an act for the said purpose and that it is expedient to grant the prayer of the said petition.

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The clerkship and indenture of clerkship of the said Francis Mackay are regularized and his clerkship shall be reckoned from the 14th July 1908 as though he had been under indenture from that date. Clerkship, &c., of F. Mackay regularized.

**2.** The Board of Notaries of the Province of Quebec is authorized to admit the said Francis Mackay at its meeting to be held in July 1911, or at any subsequent meeting, to the examination for the admission to practise of the notarial profession upon his production of the degree of Bachelor of Law or of licentiate of law from Laval University and a certificate from his patron certifying that he had attended his office from the 14th July, 1908, and on his passing the examination to admit him to the exercise of the profession of a notary. Board of Notaries of P. Q. authorized to admit F. Mackay, &c.

**3.** This act shall come into force on the day of its sanction. Coming into force.

#### C H A P . 1 4 4

An Act to regularize the clerkship and indenture of clerkship  
of Jules Joseph Arthur Pérodeau.

[Assented to 14th March, 1911]

**W**HEREAS Jules Joseph Arthur Pérodeau, law student of the city of Montreal, has by his petition represented, Preamble.

That with a view of studying for the notarial profession he began to attend and continued to attend the law lectures at Laval University in Montreal, from the month of September 1909 and attended and continued to attend as clerk from the 1st December 1909 the office of Mr. H. M. Marler, notary, at Montreal, with whom he passed an indenture of clerkship before G. H. Demers, notary, on the 2nd December, 1909 ;

That he was admitted to the study of the notarial profession by the Board of Notaries at its July session 1910, upon the production from Laval University of a degree of Bachelor of Letters and upon having obtained from the Board of Notaries his certificate of admission to the study of the notarial profession, dated 12th July, 1910 ;

That without the benefit of an act for the purpose hereinafter mentioned he would suffer considerable delay which would cause him damage ;

That he obtained the consent of the Board of Notaries to present a bill before the Legislature of Quebec for the purpose of regularizing his clerkship and indenture and of having his clerkship date from the 2nd December, 1909 ;
