The Board of Notaries of the Province of Quebec is authorized to admit the said Francis Mackay at its meeting to be held in July 1911, or at any subsequent meeting, to the examination for the admission to practise of the notarial profession upon his production of the degree of Bachelor of Law or of licentiate of law from Laval University and a certificate from his patron certifying that he had attended his office from the 14th July, 1908, and on his passing the examination to admit him to the exercise of the profession of a notary. #### C H A P . 1 4 4

An Act to regularize the clerkship and indenture of clerkship  
of Jules Joseph Arthur Pérodeau.

[Assented to 14th March, 1911]

**W**HEREAS Jules Joseph Arthur Pérodeau, law student of the city of Montreal, has by his petition represented, Preamble.

That with a view of studying for the notarial profession he began to attend and continued to attend the law lectures at Laval University in Montreal, from the month of September 1909 and attended and continued to attend as clerk from the 1st December 1909 the office of Mr. H. M. Marler, notary, at Montreal, with whom he passed an indenture of clerkship before G. H. Demers, notary, on the 2nd December, 1909 ;

That he was admitted to the study of the notarial profession by the Board of Notaries at its July session 1910, upon the production from Laval University of a degree of Bachelor of Letters and upon having obtained from the Board of Notaries his certificate of admission to the study of the notarial profession, dated 12th July, 1910 ;

That without the benefit of an act for the purpose hereinafter mentioned he would suffer considerable delay which would cause him damage ;

That he obtained the consent of the Board of Notaries to present a bill before the Legislature of Quebec for the purpose of regularizing his clerkship and indenture and of having his clerkship date from the 2nd December, 1909 ;

Whereas the petitioner has prayed for the passing of an act for the purposes hereinafter mentioned and that it is expedient to grant the said prayer :

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

**1.** The clerkship and indenture of clerkship of the said Jules Joseph Arthur Pérodeau are hereby regularized and his clerkship shall count from the 2nd December, 1909, notwithstanding any provisions to the contrary.

## C H A P . 1 4 5

An act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Charles Dumontier to the practice of medicine, surgery and obstetrics, after examination

[*Assented to 14th March, 1911*]

Preamble.

**W**HEREAS, Charles Dumontier, of St. Barthélemi, district of Joliette, has, by his petition, represented :

That he followed a course of classical studies partly at the Joliette Seminary and partly with Mr. de Kermenon, in the city of Montreal ;

That he obtained a diploma of Bachelor of Letters in the month of June 1907, and that of Bachelor of Sciences on the 7th July, 1909 ;

That he entered Laval University, in Montreal, in September 1907, and from that date regularly followed the course of lectures of the Faculty of medicine ;

That, without the benefit of an act authorizing the College of Physicians and Surgeons of the Province of Quebec to grant him, after examination, a license to practise, he will suffer considerable delay which will cause him very great damage ;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him, after examination, the necessary license to practise his profession ;

Whereas the petitioner has prayed for the passing of an act to the above effect and it is expedient to grant the prayer contained in the said petition ;
