

Whereas the petitioner has prayed for the passing of an act for the purposes hereinafter mentioned and that it is expedient to grant the said prayer :

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

Clerkship, of J. J. A. Péro-
deau, regula-
rized, &c. **1.** The clerkship and indenture of clerkship of the said Jules Joseph Arthur Pérodeau are hereby regularized and his clerkship shall count from the 2nd December, 1909, notwithstanding any provisions to the contrary.

Coming into force. **2.** This act shall come into force on the day of its sanction.

C H A P . 1 4 5

An act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Charles Dumontier to the practice of medicine, surgery and obstetrics, after examination

[Assented to 14th March, 1911]

Preamble.

WHEREAS, Charles Dumontier, of St. Barthélemi, district of Joliette, has, by his petition, represented :

That he followed a course of classical studies partly at the Joliette Seminary and partly with Mr. de Kermeno, in the city of Montreal ;

That he obtained a diploma of Bachelor of Letters in the month of June 1907, and that of Bachelor of Sciences on the 7th July, 1909 ;

That he entered Laval University, in Montreal, in September 1907, and from that date regularly followed the course of lectures of the Faculty of medicine ;

That, without the benefit of an act authorizing the College of Physicians and Surgeons of the Province of Quebec to grant him, after examination, a license to practise, he will suffer considerable delay which will cause him very great damage ;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him, after examination, the necessary license to practise his profession ;

Whereas the petitioner has prayed for the passing of an act to the above effect and it is expedient to grant the prayer contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the

Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Charles Dumontier among its members, after examination, and to grant him the necessary license to practise medicine, surgery and obstetrics.
2. This act shall come into force on the day of its sanction.

C H A P . 1 4 6

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit J. Charles Routhier to the practice of medicine, surgery and obstetrics.

[Assented to 24th March, 1911]

WHEREAS J. Charles Routhier, physician and surgeon of Lorrainville, Duhamel township, Ottawa county, Province of Quebec, has, by his petition, represented :

That, in June 1908, he obtained a diploma of Doctor of Medicine and Surgery of Laval University, in Montreal, after following the regular courses of the said school during the period required by law;

That he began to follow the courses of the said school before obtaining his certificate of admission to the study of medicine;

That he possesses the necessary qualities to practise medicine, surgery and obstetrics ;

That he cannot now obtain his license to practise medicine, surgery and obstetrics in the Province of Quebec, without a special authorization of the Legislature ;

That, in consequence of the above he suffers delay which causes him damage;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him the necessary license for the practice of his profession ;

And whereas it is expedient to grant the prayer to that effect contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said J. Charles Routhier
