

Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Charles Dumontier among its members, after examination, and to grant him the necessary license to practise medicine, surgery and obstetrics. College of P. and S. of P. Q. authorized to admit C. Dumontier after examination.
2. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 4 6

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit J. Charles Routhier to the practice of medicine, surgery and obstetrics.

[Assented to 24th March, 1911]

WHEREAS J. Charles Routhier, physician and surgeon of Preamble.
Lorrainville, Duhamel township, Ottawa county, Province of Quebec, has, by his petition, represented :

That, in June 1908, he obtained a diploma of Doctor of Medicine and Surgery of Laval University, in Montreal, after following the regular courses of the said school during the period required by law;

That he began to follow the courses of the said school before obtaining his certificate of admission to the study of medicine;

That he possesses the necessary qualities to practise medicine, surgery and obstetrics ;

That he cannot now obtain his license to practise medicine, surgery and obstetrics in the Province of Quebec, without a special authorization of the Legislature ;

That, in consequence of the above he suffers delay which causes him damage;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him the necessary license for the practice of his profession ;

And whereas it is expedient to grant the prayer to that effect contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said J. Charles Routhier Coll. of P. and S. of P. Q. author-

C H A P . 1 4 7

An Act to authorize the college of Physicians and Surgeons of the Province of Quebec, to admit David Tannenbaum to the practice of medicine, surgery and obstetrics.

[Assented to 14th March, 1911]

Preamble.

WHEREAS David Tannenbaum, physician, of the city of Montreal, has, by his petition, represented :

That on the 12th day of June, 1909, he obtained a diploma of doctor of medicine from McGill University, Montreal ;

That he began to follow the lectures of the medical faculty of the said University before having obtained a certificate of admission to study, which he obtained on the 29th day of September, 1907, from the College of Physicians and Surgeons of the Province of Quebec, by registering with its registrar a degree of Bachelor of Arts, which he obtained from McGill University on September 19th 1907 ;

That he is qualified to practise medicine but that he cannot obtain his license to practise until he has completed his four years of study as a medical student dating from September 29th, 1907, and until he shall have passed examinations set by the College of Physicians and Surgeons of the Province of Quebec ;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec to the passing of an Act to authorize the said College of Physicians and Surgeons of the Province of Quebec to grant him his license on his passing his examinations ;

And whereas, he has prayed that an act be passed to that effect and it is expedient to grant the prayer of the said petitioner ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said David Tannenbaum among its members on his having passed the examinations required by the said College of Physicians and Surgeons.
