EXECUTIVE COUNCIL CHAMBER

QUEBEC, 24th July, 1909.

PRESENT : THE LIEUTENANT-GOVERNOR in Council.

Whereas it is advisable to lower the fees payable by Charitable Societies, as fixed by section "C" of the tariff of Fees established by Order in Council, approved on the 12th February, 1909.

That section "D" of the said Order in Council should be altered so as to include all Mutual Benefit Associations incorporated outside the Province of Quebec, not authorized by the Dominion Government.

It is ordered that pursuant to article 229 of the Quebec Insurance Act 8 Ed. VII, Ch. 69 :—

1. Section "C" of the said Order in Council be replaced by the following :

C. Fees exigible from Mutual Benefit Associations constituted by this Province :

1. On authorization to form an Association including initial license..... \$ 25 00
2. On each renewal license..... 10 00
3. On revivor license after suspension..... 10 00

Fees exigible from Charitable Associations constituted by this Province :—

1. On authorization to form an Association including initial license..... 5 00
2. On renewal of license..... 1 00

2.—That the heading of section “ D ” be changed to read as follows :—

D. Fees exigible from Mutual Benefit Associations other than those constituted by this Province and not authorized by license issued in conformity with the Insurance Act of Canada.

EXECUTIVE COUNCIL CHAMBER

QUEBEC, 18th July, 1910.

PRESENT : THE LIEUTENANT-GOVERNOR in Council.

Whereas it is advisable that no license fees be exacted from Mutual Insurance Companies against fire, lightning and wind, organized by municipal councils or by individuals, in conformity with articles 6870 and 6886 R.S.P.Q., 1909, or organized prior to the passing of the Quebec Insurance Act, under articles 5349 and 5369 R.S.P.Q., 1888, other than a fee of \$20.00 for the original license granted under article 6850 of the R.S.P.Q., 1909, and

Whereas it is advisable that no fees be exacted from Mutual Benefit or Charitable Associations constituted by this Province.

It is ordered that pursuant to article 7065 of the R.S.P.Q., 1909, the tariff of fees and dues established by order in Council approved by the Lieutenant-Governor on the 12th of February, 1909, and amended by Order in Council dated the 24th July, 1909, be further amended as follows :—

Section “ B ”—Items 4 and 5.—

After the word “ mutual ” in the fourth line, add the words “ excepting mutual insurance companies against fire, lightning and wind organized by municipal councils or by individuals,”

Add the following item :—

“ 10. On original license to transact the business of a mutual insurance company against fire, lightning and wind organized by municipal councils or by individuals. \$ 20 00”

Section “ C ” shall be struck out.

EXECUTIVE COUNCIL CHAMBER

QUEBEC, 7th July, 1910.

PRESENT : THE LIEUTENANT-GOVERNOR in Council.

Whereas by the act 1 George V, chapter 3, it is enacted that timber cut on lands granted as subsidies in pursuance of the acts 6 Edward VII, chapter 4 and 8 Edward VII, chapter 5, to certain companies mentioned in the said acts, shall be subject to any regulation ordering the manufacture thereof within the limits of Canada, which the Lieutenant-Governor in Council may enact ;

It is decreed that timber cut on lands granted as subsidies to the railway companies mentioned in the acts 6 Edward VII, chapter 4 and 8 Edward VII, chapter 5, shall be manufactured in Canada, within the meaning of article 13 of the woods and forests regulations now in force, and that the said article 13 of the said regulations shall apply to such timber in the same way as to timber cut on Crown lands.

Nevertheless this regulation shall not apply to the railway companies mentioned in the acts aforesaid, which have already entered into the contracts provided for by section 7 of the act 6 Edward VII, chapter 4 or by section 7 of the act 8 Edward VII, chapter 5, as the case may be.

EXECUTIVE COUNCIL CHAMBER

QUEBEC, 7th July, 1910.

PRESENT : THE LIEUTENANT-GOVERNOR in Council.

In pursuance of article 7520 of the Revised Statutes of Quebec, 1909, it is decreed that on and after the first day of September next, 1910, the tariff of registrars' fees in the Province of Quebec, be amended as follows :—

(a) By replacing the first paragraph of the first item by the following :

“ 1. For the registration at length of any title or document, or for the registration by memorial of a summary of the same, if the number of words do not exceed 400.....\$1.00 ”

(b) By replacing item 8 by the following :

“ 8. For the filing of any document authorizing a cancellation, including the documents annexed.....\$.80 ”
