CHAP. 10

An Act to amend the Quebec License Law and the Closing of Taverns Act

[Assented to 4th June, 1910]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

R. S. Q., 904 amended. Sales by bottlers. **1.** Article 904 of the Revised Statutes, 1909, is amended by adding the following sub-paragraph to paragraph 17 thereof "In the cities of Quebec, Montreal and Three Rivers bottlers are forbidden to sell to any other persons than those holding licenses for the sale of intoxicating liquors."

Id., 930 amended. Withdrawal of signature from certificate. **2.** Article 930 of the said statutes is amended by replacing the last paragraph by the following: "Any elector who has signed such certificate may appear in person before the authorities having authority to confirm such certificate, and withdraw his signature."

Id., 936 amended. **3.** Article 936 of the said statutes is amended by adding at the end of paragraph 4, the words "within the fifteen years previous."

Id., 943 amended. Maximum in Nicolet. **4.** Paragraph 4 of article 943 of the said statutes is amended : (a) By adding after the word : "section" in the twenty second line, the words . "in the town of Nicolet, to a maximum of three, until the population of the said town shall number five thousand."

And in Levis. (b) By adding at the end thereof the words . "In the town of Levis the number of hotel licences is limited to a maximum of six (the present number) until the population of the said town numbers twelve thousand."

Id., 988 amended. **5.** Article 988 of the said statutes is amended by replacing sub-paragraphs b and c of paragraph 16 by the following : "(b) In any other territory, five dollars";

Christmas Day, New Year's Day or Good Friday unless
upon a special certificate for medicinal purposes, signed by
a duly registered medical practitioner or by a clergyman,
and produced by the purchaser. On Saturdays the sale of such
liquors is prohibited from and after the hour of seven in the
evening, save upon special certificate as hereinabove provided."

8. Article 1055 of the said statutes is replaced by the follow- Id. 1055
ing replaced.

" 1055. Intoxicating liquors shall not be sold in any Time when
licensed liquor shop or in the dependencies thereof, nor by intoxicants
any bottler between the hour, in cities and towns of eleven not to be sold
o'clock, and in any other place, of ten o'clock in the evening in shops, &c.
of any week day and the hour of seven o'clock in the
forenoon of the following day, or at any time during Sunday,
Christmas Day, New Year's Day or Good Friday, except
in retail liquor shops in which intoxicating liquor may be
sold upon a special certificate or medicinal purposes, signed
by a duly registered medical practitioner or by a clergyman,
and produced by the purchaser ; but on Saturdays the sale
of such liquor is prohibited from and after the hour of seven
in the evening, save upon special certificate as hereinabove
provided."

" 1055a. Every holder of an inn license, of a restaurant Keeping of
license or of a shop license, shall keep each certificate which licence certi-
he has received in compliance with articles 1054 and 1055, ficates."

9. Article 1056 of the said statutes is amended:

(a) by replacing the first paragraph by the following :

Closing of
shops, &c.

" **1056.** All such licensed liquor shops and bottlers' establishments shall be kept closed during the days and hours mentioned in article 1055; but any such licensed liquor shop in which groceries or other articles besides intoxicating liquors are sold, may, except on Sunday, Christmas Day, New Year's Day and Good Friday, be kept open for the sale of such groceries or such other articles between the hours of four o'clock in the morning and midnight."

Proviso.

(b) By replacing the words " The holder of a shop license or bottler's license, or one of his employees, may enter his establishment during such time " in the first and second lines of the second paragraph, by the words : " During the time when liquor shops and bottlers' establishments must remain closed, the holder of a shop license or bottler's license, or one of his employees, may enter his shop or bottling establishment. "

10. Article 1057 of the said statutes is replaced by the following :

When intoxic-
icants not to
be delivered
in bar, &c.

" **1057.** Intoxicating liquors sold under the provisions of articles 1054 and 1055 during the time when hotels and restaurants must be closed, or during the time when no intoxicating liquor can be sold in liquor shops, shall not be delivered in the bar or shop, as the case may be, and the purchaser shall not be admitted into such bar or shop."

11. Article 1104 of the said statutes is replaced by the following

Early closing
by-laws.

" **1104.** The municipal councils of cities and towns may pass by-laws for the closing at ten o'clock in the evening on Monday, Tuesday, Wednesday Thursday and Friday of each week of the bars in hotels and restaurants, and to enact that no intoxicating liquor shall be sold in shops or in bottlers' establishments after ten o'clock in the evening on such days ; and in such case the said bars shall remain closed and no intoxicating liquors shall be sold in the said shops and establishments until seven o'clock in the morning of the next day.

Penalty for
infraction.

Every such by-law which applies to hotels, restaurants, shops and bottler's establishments in the municipality shall

impose a penalty of not more than fifty dollars for each offence and in default of payment imprisonment for not more than three months.

12. Article 1263 of the said statutes is amended by striking out the words " hotel or " in the first line. Id. 1263 amended.

13. Article 1329 of the said statutes is replaced by the following : Id. 1329 replaced.

" **1329.** Every person licensed to sell and every person who sells by retail in quantities less than one pint, imperial measure, in any city, town, village or parish, intoxicating liquors, wine, beer and temperance liquors, shall close the house or building in which such person sells or causes to be sold or allows such liquors to be sold, between the hours, in cities and towns, of eleven o'clock and in any other place of ten o'clock in the evening of every week day and the hour of seven o'clock in the forenoon of the following day, and at all times during Sunday, Christmas Day, New Year's Day or Good Friday, and shall not during such days and hours, sell or cause or permit to be sold therein such liquors, unless upon a special certificate for medicinal purposes, signed by a duly registered medical practitioner or by a clergyman, and produced by the purchaser ; but on Saturdays he shall close such house or building at seven o'clock in the evening. Closing of house, &c., where liquor sold, during certain times.

This article shall not apply to druggists duly registered under the Quebec Pharmacy Act. Druggists not affected.

Every person offending against any of the provisions of this article shall incur the penalties imposed by article 1072." Penalty.

14. This act shall come into force on the 1st juridical day of May 1911. Coming into force.

CHAP. 11

An Act to amend the act providing for a tax on transfers of shares, bonds, debentures or debenture stock
