" **1329.** Every person licensed to sell and every person who sells by retail in quantities less than one pint, imperial measure, in any city, town, village or parish, intoxicating liquors, wine, beer and temperance liquors, shall close the house or building in which such person sells or causes to be sold or allows such liquors to be sold, between the hours, in cities and towns, of eleven o'clock and in any other place of ten o'clock in the evening of every week day and the hour of seven o'clock in the forenoon of the following day, and at all times during Sunday, Christmas Day, New Year's Day or Good Friday, and shall not during such days and hours, sell or cause or permit to be sold therein such liquors, unless upon a special certificate for medicinal purposes, signed by a duly registered medical practitioner or by a clergyman, and produced by the purchaser ; but on Saturdays he shall close such house or building at seven o'clock in the evening. Closing of house, &c., where liquor sold, during certain times.

This article shall not apply to druggists duly registered under the Quebec Pharmacy Act. Druggists not affected.

Every person offending against any of the provisions of this article shall incur the penalties imposed by article 1072." Penalty.

14. This act shall come into force on the 1st juridical day of May 1911. Coming into force.

CHAP. 11

An Act to amend the act providing for a tax on transfers of shares, bonds, debentures or debenture stock

[Assented to 4th June, 1910]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 1360 of the Revised Statutes, 1909, is amended by replacing the words "except upon the first issue of shares up R. S. Q. 1360 amended.

to the sum of one million dollars" in the sixth, seventh and eight lines, by the words : " but the first delivery by the corporation or company, of such shares, bonds, debentures or debenture stock, in order to effect an issue, is not subject to the tax imposed by this article."

CHAP. 13

An Act to amend the Revised Statutes 1909, respecting agricultural societies
