

CHAP. 31

An Act to amend the Revised Statutes. 1909 respecting
Dentists

[*Assented to 4th June, 1910*]

HIS MAJESTY, with the advice and consent of the Legislative Council and the Legislative Assembly of Quebec, enacts as follows :

R.S.Q., 5043, amended. **1.** Article 5043 of the Revised Statutes, 1909 is amended by striking out the last paragraph.

Coming into force. **2.** This act shall come into force on the day of its sanction.

CHAP. 32

An Act to amend the Veterinary Surgeons' Act of the Province of Quebec.

[*Assented to 4th June, 1910*]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

R. S. Q. 5087 amended. **1.** Article 5087 of the Revised Statutes, 1909, is amended by adding the following after the second paragraph :

Service upon College. “ The service of any process upon the College shall be made upon the president or secretary of the College according to the usual rules.”

Id., 5100 amended. **2.** Article 5100 of the said statutes is amended by replacing all the words after the words “veterinary surgeon” in the fourth line of the first paragraph, by the words : “and who has had no revenues other than those derived from the practice of the veterinary art, shall be entitled hereafter—subject to the provisions of this section, and provided he applies therefor before the 30th September 1910—to be placed on a separate register under the title of “Veterinary”.

Id., 5104 amended. **3.** Article 5104 of the said Statutes is amended by inserting the following after the second paragraph :

Penalty for “ Every person qualified to be registered as a veterinary

surgeon, under the provisions of this section, and practising neglect to the profession of veterinary surgeon, who neglects or refuses to register. have himself registered as aforesaid within three months from the date indicated in the written notice given him by the Secretary of the College, is guilty of an offence and liable to a penalty of fifty cents for every day he so remains unregistered."

4. Article 5115 of the said statutes is replaced by the following: Id., 5115 replaced.

"5115. This section shall not in any way effect any person practising castration of animals. Certain persons not affected.

5. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 33

An Act to amend the Revised Statutes, 1909, respecting the declaration to be made by incorporated companies

[Assented to 4th June, 1910]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Article 6095 of the Revised Statutes, 1909, is amended R. S. Q. 6095 amended by adding the following paragraphs :

"Notwithstanding any provision of law concerning pre-Action prescription, an action may be taken against the company, its president, principal manager, or chief agent, for contravention of this section, so long as the company continues to carry on any enterprise, trade or business without complying with this section. Action against president, &c., of company.

Nevertheless if the company ceases to carry on any enterprise, trade or business, without having complied, in due time, with this section, an action may be taken against it, its president, principal manager or chief agent, whether such persons are or are not still in office, within two years from the last day on which the company carried on such enterprise, trade or business."

2. This act shall come into force on the day of its sanction. Coming into force.
