

CHAP. 93

An act to incorporate the "Old Boys of Bishops' College School".

[Assented to 4th June, 1910]

WHEREAS the Very Reverend Lennox Waldron Williams; Preamble.
John Hamilton; the Venerable Archdeacon Balfour;
Colonel J. B. Forsyth; Robert Campbell; E. J. Hale; Colonel
G. E. A. Jones; James Laurie; R. Harcourt Smith; H. Porteous;
Charles F. C. Porteous; Colonel G. Rolt White, all of the city
of Quebec; C. M. Holt; G. R. Hooper; G. H. Carter; F. Hough-
ton; C. Gordon MacKinnon, and Maurice Burke, all of the
city of Montreal, have by their petition represented that they
wish to form an association under the name of the "Old
Boys of Bishops' College School," to unite the former pupils
of the said school and to promote the progress and advance-
ment of the said school.

And whereas it is expedient to grant the prayer of the said
petitioners.

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:—

and Maurice N. Burke, all of Montreal, former pupils at
Bishops College School, Lennoxville and all such other former
pupils of the said school who shall be admitted to form part
thereof, are incorporated as an association under the name
of the "Old Boys of Bishop's College School". Name.

2. The objects of the said association are to unite the former Objects.
pupils of the said school and to promote the progress and
advancement of the said school.

3. (a) The association shall have all the powers conferred Powers.
by law on corporations as well as those that may be necessary
to enable it to attain its objects;

(b) Power to impose such annual assessments and contributions upon its members as may be ordered under its by-laws; to acquire under any title whatsoever and to hold and administer, moveable and immoveable property, such immoveable property not to exceed two hundred thousand dollars in value, and dispose of the same according to its by-laws.

(c) The right to make by-laws for its own government and for the administration and disposal of its property and for the hypothecation of its immoveables.

Management.

4. The affairs of the association shall be managed and administered by the officers, boards and committees established under the by-laws of the association.

Head office.

5. The head office of the association shall be at Lennoxville or at such other place in the Province as may be established under its by-laws after approval by the Lieutenant-Governor in Council and notice in the *Quebec Official Gazette*.

Transmission of statement.

6. The association shall transmit to the Lieutenant Governor in Council whenever required so to do, a detailed statement of its immoveables, a copy of its by-laws and the name of its officers.

Coming into force.

7. This act shall come into force on the day of its sanction.

CHAP. 94

An Act to incorporate *La Ligue Antituberculeuse de Québec*

[Assented to 4th June, 1910]

Preamble.

WHEREAS Sir François Langelier, acting chief justice of the Superior Court in Quebec; Sir George Garneau; Honourable Louis Philippe Pelletier, King's Counsel; Michael Ahern, physician; Michel Delphis Brochu, physician; Arthur Simard, physician; Arthur Rousseau, physician; C. Rosaire Paquin, physician; Alfred Morisset, physician and member of the Legislative Assembly, have, by their petition, represented that they have decided to establish an association with the object of contending against tuberculosis and against its progress and have for such purpose prayed to be incorporated under the name of "*La Ligue antituberculeuse de Québec*"; and
