

(b) Power to impose such annual assessments and contributions upon its members as may be ordered under its by-laws; to acquire under any title whatsoever and to hold and administer, moveable and immovable property, such immovable property not to exceed two hundred thousand dollars in value, and dispose of the same according to its by-laws.

(c) The right to make by-laws for its own government and for the administration and disposal of its property and for the hypothecation of its immovables.

Management.

4. The affairs of the association shall be managed and administered by the officers, boards and committees established under the by-laws of the association.

Head office.

5. The head office of the association shall be at Lennoxville or at such other place in the Province as may be established under its by-laws after approval by the Lieutenant-Governor in Council and notice in the *Quebec Official Gazette*.

Transmission of statement.

6. The association shall transmit to the Lieutenant Governor in Council whenever required so to do, a detailed statement of its immovables, a copy of its by-laws and the name of its officers.

Coming into force.

7. This act shall come into force on the day of its sanction.

CHAP. 94

An Act to incorporate *La Ligue Antituberculeuse de Québec*

[Assented to 4th June, 1910]

Preamble.

WHEREAS Sir François Langelier, acting chief justice of the Superior Court in Quebec; Sir George Garneau; Honourable Louis Philippe Pelletier, King's Counsel; Michael Ahern, physician; Michel Delphis Brochu, physician; Arthur Simard, physician; Arthur Rousseau, physician; C. Rosaire Paquin, physician; Alfred Morisset, physician and member of the Legislative Assembly, have, by their petition, represented that they have decided to establish an association with the object of contending against tuberculosis and against its progress and have for such purpose prayed to be incorporated under the name of "*La Ligue antituberculeuse de Québec*"; and

Whereas such an association would be one of public utility, and it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the

Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The persons above mentioned, together with all others Persons in- who may join them and become members of the association corporated. under such by-laws as it may make, are incorporated under the name of "*La Ligue antituberculeuse de Québec*," hereinafter called Name. "The League," for the objects mentioned in the preamble.

2. The corporate seat of the league shall be in Quebec, and Corporate it may exercise its powers within the same territory as that seat. of the Court of King's Bench sitting in appeal in Quebec.

3. The league shall have all the powers and rights which Powers, &c., belong to civil and commercial corporations, including that of of league. holding, acquiring, hypothecating and alienating immovables, the value whereof shall not exceed twenty-five thousand dollars.

4. The means of action of the league shall be : Means of

1. The diffusion among the masses of useful knowledge for action. preventing and contending against tuberculosis ;

2. The establishment, organization and maintenance of all necessary or useful works and buildings for carrying out the object of the league.

5. The league may consist : How league

a. Of a central section ;

b. Of local sections ;

c. Of affiliated or associated sections ;

d. Of isolated members.

6. The seat of the central section shall be in Quebec at the Seat of cen- corporate seat of the league whereof it shall be the nucleus ; tral section, it shall pass by-laws, establish the amount of the contributions &c. and adopt regulations for its internal government, as well as those it may deem advisable to apply to the local sections and affiliated or associated societies. Its officers shall be those of the general board.

7. The local sections shall be under the direction of the Direction of central section in accordance with such by-laws as the latter of local sec- may adopt. tions.

8. Every person approved by the general council may have Entry as himself entered directly at the central section as an isolated isolated member ; every person belonging to an antituberculosis member.

society shall be *ex officio* a member of the league on condition that he apply therefor.

General council.

9. The society shall be managed by a general council composed of such persons as may be determined by the by-laws the league may deem expedient to adopt.

Appointment of members of council.

10. The members of the council shall be appointed by the general meeting of the members of the league, to be held annually and it may also elect honorary officers.

Resources of league.

11. The resources of the league shall consist of the property and revenues of all kinds belonging to it and all the proceeds of :

1. The annual contributions ;
2. All gifts and legacies made to it and which it is authorized to accept ;
3. The receipts of all kinds which may be realized.

By-laws.

12. The council may make all by-laws necessary for the attainment of the object the league has in view.

Transmission of statement.

13. The corporation shall transmit to the Lieutenant-Governor in Council, whenever thereunto required by the Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and by-laws.

Members not personally liable.

14. The members shall not be personally liable for any of the debts or obligations of the league.

Coming into force.

15. This act shall come into force on the day of its sanction.

CHAP. 95

An Act to incorporate the Bacon Industrial School for Girls

[Assented to 4th June, 1910]

Preamble.

WHEREAS the Reverend Albert Stevens, rector of Coatimcook and John Putney Bowen, of Hatley, have by their petition represented;

That Miss Emily Bacon by her last will and testament and codicils thereto did bequeath all her property real and personal unto the said petitioners in trust for establishing and maintaining a manual labor school for girls;
