

CHAP. 104

An Act respecting the building of a church and sacristy of the parish of St. Paul de Montréal

[Assented to 4th June, 1910]

Preamble.

WHEREAS the trustees of the parish of St. Paul de Montréal, appointed by the act 63 Victoria, chapter 96, have by their petition represented:

That on the 12th October, 1907, the church was again destroyed by fire, and that the parish of St. Paul de Montréal is therefore obliged to rebuild it;

That for such purpose, new trustees have been appointed: Alfred B. Baron, Moïse Jodoin, junior, Evariste Desparois, Frédéric Wait, Théodore St. Germain and Joseph Godin, and it is more expedient that there should be but one and the same corporation of trustees;

That the corporation of trustees appointed by the act 63 Victoria, chapter 96 consents to be abolished;

That it is necessary to amend the act 63 Victoria, chapter 96 in order to authorize the employment of the amount received from the insurance companies and to borrow the surplus money required for the said rebuilding;

That it is necessary to amend the act 1 Edward VII, chapter 83, to change the date of the assessment;

That the Catholic freeholders of the said parish have approved of the said petition;

That it is necessary that a special act be passed to that effect;

Whereas it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Persons incorporated.

1. Alfred B. Baron, Moïse Jodoin, junior, Evariste Desparois, Frédéric Wait, Théodore St. Germain and Joseph Godin are hereby appointed and constituted trustees and shall form a corporation under the name of the "Trustees of the parish of St. Paul de Montréal."

Name.

Trustees may build church, &c.

2. The trustees may rebuild a church and sacristy in the parish of St. Paul de Montréal, in accordance with plans and specifications to be approved by competent authority. Such plans and specifications may, however, be altered or changed by the same authority if necessary.

3. Sections 2, 3, 4, 6, 7, 10, 12, 14, 15, 16, 18, 19 and 22 of the act 63 Victoria, chapter 96, and section 13 as amended by

the act 1 Edward VII, chapter 83, section 2; section 13a, as amended by the act 1 Edward VII, chapter 83, section 3; section 17 as amended by the act 1 Edward VII, chapter 83, section 4; of the act 63 Victoria, chapter 96, shall apply to the corporation hereby constituted and shall govern the same.

4. To provide for the payment of the cost of building here-
by authorized, the trustees may use the sum of thirty thousand dollars which the trustees appointed by the act 63 Victoria, chapter 96, have received from the insurance companies.

5. The new trustees are authorized to borrow a further sum, not exceeding ten thousand dollars, for the purposes of the said building, by means of ordinary debentures as may be deemed necessary on the security of *L'œuvre et Fabrique* of the parish of St. Paul de Montréal, which shall bind itself with the trustees to pay the interest and repay the capital.

6. The corporation hereby constituted shall succeed to all the rights, privileges and obligations of the corporation constituted by the act 63 Victoria, chapter 96 and its amendments.

7. The corporation hereby constituted shall, in the place and stead of the corporation constituted by the act 63 Victoria, chapter 96 and its amendments, have all the same powers and obligations as the said corporation and carry out the said law for it.

8. Sections 8 and 9 of the act 63 Victoria, chapter 96 shall not apply to the loan authorized by this act but, in so far as regards the carrying out of the act 63 Victoria, chapter 96, the said sections are replaced by the following:

“**8.** During the period that will elapse until the date of the repayment of the debentures already issued for the building of the church and sacristy destroyed by fire, the assessment shall be used:

1. To pay the interest on the debentures, the cost of management and to gradually clear off the deficit of sixteen hundred and eighty-three dollars and forty cents, created by the various amounts which had to be borrowed every year owing to the insufficiency of the assessment to pay the cost of administration and complete the payment of the interest;

2. To create a sinking fund of three hundred dollars per annum, for ten years from the date of the passing of this act and of nine hundred dollars per annum for the remainder of the time, until such sinking fund, invested at compound interest, is sufficient to pay the debentures.”

Deposit of sinking fund. **9.** The money intended for the sinking fund shall be deposited as it is received by the trustees, in a chartered bank, or loaned to religious or other non-commercial corporations, if it be advantageous to do so.

Secretary-treasurer. **" 20.** The trustees shall exact a security of at least fifteen hundred dollars from the secretary-treasurer."

Id., s. 21 replaced. **11.** Section 21 of the said act is replaced by the following:

Insurance of buildings. **" 21.** The trustees shall keep the said buildings insured against fire to a sum equal to the total amount of the assessment and of the loan hereby authorized."

Coming into force. **12.** This act shall come into force on the day of its sanction.

CHAP. 105

An Act respecting the building of the church, sacristy and rectory of the parish of St. Viateur d'Outremont

[Assented to 4th June, 1910]

Preamble.

WHEREAS the parish priest and church-wardens of *L'œuvre et Fabrique* of the parish of St. Viateur d'Outremont, have, by their petition, represented :

That it is urgent for the good of the parish to build as soon possible, on the ground held for the purpose by the *fabrique*, a church, sacristy and a rectory ;

That it is necessary to have special legislation respecting such buildings, their cost and the method of effecting a loan for the same ;

That the freehold inhabitants have unanimously approved such petition ;

Whereas it is prayed that an act be passed for the purpose and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Certain assessment authorized, &c.

1. The church-wardens of the parish of St. Viateur d'Outremont, in the district of Montreal, may levy by an act of assessment upon all the immoveables of the parish belonging to Roman Catholics, a yearly amount not exceeding twenty
