An Act to amend the Cities and Towns' Act, 1903

[Assented to 29th May, 1909.]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Paragraph 3 of article 386 of the act 3 Edward VII, chapter 38, is amended by adding thereto the following : “ or at the expense of the abutting owners or the owners on the opposite side of the street or of part of the municipality, by means of a special assessment upon such owners.”

C H A P . 60

An Act to amend the Joint Stock Companies' Incorporation Act and the Quebec Companies' Act, 1907

[Assented to 27th April, 1909]

HIS MAJESTY, with the advice and consent of the Legislative Council and the Legislative Assembly of Quebec, enacts as follows :

1. 1. The following article is inserted in the Revised Statutes after article 4704*b*, as enacted by the act 4 Edward VII, chapter 33, section 1 :

“ **4704*c*.** Whenever the letters patent contain any misnomer, misdescription or other clerical error, the Provincial Secretary may, on petition of the company, if there is no adverse claim, direct such letters patent to be corrected or to be cancelled and correct ones to be issued in their stead.

Effect there-
of.

The new or corrected letters patent shall have the same effect as if correctly issued at the date of the original letters patent, and acquired rights of third persons shall not be affected by such correction or re-issue.

Notice of the correction of such letters patent or of the issue of the new letters patent, shall forthwith be given by the Provincial Secretary in the *Quebec Official Gazette*.”

2. The act 7 Edward VII, chapter 48, is amended by inserting the following article after article 10 :

" 10a. Whenever the letters patent contain any misnomer, ^{Correction} misdescription or other clerical error, the Provincial Secretary ^{or re-issue of} may, on petition of the company, if there is no adverse claim ^{letters patent} direct such letters patent to be corrected or to be cancelled and correct ones to be issued in their stead.

The new or corrected letters patent shall have the same effect ^{Effect there-} as if correctly issued at the date of the original letters patent ^{of} and acquired rights of third persons shall not be affected by ^{Proviso.} such correction or re-issue.

3. Paragraph c of article 3 of the said act, and article 13 ^{Repeals.} the eof, are repealed.

4. Form A of the said act is amended by striking out the ^{Id., Form A} words: "within the Province," in the twentieth and twenty- ^{amended.} first lines.

5. Form C, of the said act, as amended by the act 8 Ed- ^{Id., Form C} ward VII, chapter 65, section 1, is further amended by striking ^{amended.} out the words "in the Province of Quebec" in the tenth line.

CHAP. 61

An Act to amend the law respecting certain declarations to be made by certain corporations, companies, firms and persons

[Assented to 29th May, 1909]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Article 4757 of the Revised Statutes is amended : R.S.Q., 4757,
 - a. By replacing the word: "four," in the third line, by the ^{amended.} word: "two";
 - b. By replacing the words: "two hundred," in the fifth line, by the word: "one hundred."
2. Article 5639 of the Revised Statutes is amended : Id., 5639,
 - a. By inserting after the word: "section," in the third line, ^{amended.}
