

of amounts expended in connection with them, shall apply to all roads the control whereof the corporation may acquire, as aforesaid, as if they had been purchased immediately."

**5.** The council may, by by-law, when it deems it expedient in the interest of the village, make any arrangement with one or more proprietors, either for the purpose of regulating the manner of valuing his or their immoveables or for fixing the amount at which they are to be valued, for regulating the manner of taxing immoveables for ordinary or special taxes or fixing the amount at which they shall be taxed for a specified period, provided that, in any of the foregoing cases, the period does not exceed ten years, and that such by-law be ratified by the Lieutenant-Governor in Council.

It may also, by resolution, determine the delay and manner of collecting all special taxes.

**6.** The resolution adopted by the council of the village of Rosemont, on the sixteenth of December, 1908, respecting the valuation of the immoveables bearing the numbers 206 and 206-1 of the official plan and book of reference of the village of Côte de la Visitation, is ratified and confirmed.

**7.** The contract entered into on the eighth of January, 1909, before Georges Mayrand, notary, between the corporation of the village of Rosemont and the Montreal Park and Island Railway Company, as signed by the parties is ratified and confirmed and the said company shall be exempt from taxation as set forth in such contract for a period of fifty years from the above mentioned date.

**8.** This act shall come into force on the day of its sanction.

## CHAP. 94

An Act to grant certain powers to the corporation of the village of Ste. Anne de Beaupré

[Assented to 29th May, 1909]

**W**HEREAS the corporation of the village of Ste. Anne de Beaupré has, by its petition, represented that, in view of the large number of pilgrims and tourists who flock there especially in summer and who also remain there; in view of the consequent active competition between hotel-keepers, hackmen, merchants and other purveyors to obtain the strangers' custom; in view of the consequent difficulty of maintaining

order and peace, especially when there are large crowds of strangers ; in view of the necessity of providing protection and accommodation for pilgrims and travellers, it is desirable that the corporation of the village be given more extended powers suitable for such an exceptional state of affairs ;

And whereas it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

By-laws.

**1.** The village of Ste. Anne de Beaupré may pass by-laws for the following purposes :

To divide into wards, &c.

(a) To divide the municipality into wards solely for the application of the by-laws and it may make by-laws applicable solely to the ward frequented by strangers or to any other ward and extend the application of such by-laws to the other wards when the same is deemed necessary by the council ;

To prevent hotel-keepers &c., from soliciting custom on roads, &c. ;

(b) To prevent hotel and boarding-house keepers, hackmen, carters, merchants, purveyors, traders and proprietors or masters of establishments or undertakings connected with shows or any person whomsoever from soliciting custom on the roads, streets or public places ; to forbid the distribution of business cards, circulars or posters on the roads, streets or public places ; to forbid calling out to passers-by on the roads, streets or public places, also from the door-ways and galleries of houses or while standing on any private ground or in any place whatsoever ;

To regulate soliciting of custom, &c. ;

(c) To regulate the manner in which each of such persons may solicit custom and offer his wares, merchandise or services ;

To compel boarding-house keepers, &c., to post tariffs &c. ;

(d) To compel boarding-house and hotel-keepers and those who keep houses of public entertainment to post up their tariff for board in such manner as may be determined by the by-law and to deposit a copy thereof at the office of the council ;

To forbid theatrical, shows, &c. ;

(e) To secure good order and decency, also the safety and accommodation of the public, in halls and places where theatrical performances, moving pictures or other shows, lectures or entertainments are given or exhibited, to forbid such performances, to impose a tax on all or some of such performances, or entertainments as it may deem proper ;

To fix cab-stands, &c. ;

(f) To indicate the place where hackmen and carters shall stand with their horses and vehicles on the streets, roads, public places or other spots ; to forbid hackmen and carters from remaining on the streets, roads and public places except in their vehicles or near the same and from remaining on the sidewalks ; and to make a tariff for hackmen and carters and to require them to exhibit it upon demand ;

(g) To fix upon one or more places in the streets, roads or public places where persons selling articles of devotion, or other merchandise or wares may place their tables, vehicles or stalls and expose or sell such articles, merchandize or wares ; to regulate the manner in which the same shall be exposed for sale and sold, the dimensions and disposal of such vehicles, tables or stalls ; to grant licenses for the sale of such articles, wares or merchandise to such persons as it may deem it advisable to grant them, in consideration of a yearly tax or due not exceeding twenty dollars ; to limit the number of such licenses or abolish them altogether ;

To fix places on streets for sales of certain articles, &c. ;

(h) To refuse licenses to boarding-housekeepers who have not complied with the laws of the Province of Quebec respecting public buildings, for protection against fire and the enforcement of the laws of hygiene ;

To refuse licenses to certain persons, &c. ;

(i) To order the closing of any public building not approved by a certificate of the inspectors of public buildings as regards protection against fire and hygiene ; to exact the production of such certificate and to authorize any policeman or constable to prevent the use of such buildings and forbid the public entrance thereto unless such certificate be previously produced ;

To order closing of certain public buildings, &c. ;

j. To refuse to grant or renew the license of any boarding-housekeeper whenever it is established before the council to its satisfaction, that he has, during the year preceding the application for a license, overcharged travellers or caused or allowed serious disturbances to occur in his boarding-house ;

To refuse to grant, &c., certain licenses in case of overcharge, &c. ;

(k) To establish a police station and a lock-up for persons arrested by the policemen or constables while awaiting judgment on the complaint laid against them, on the facts that have given rise to their arrest ;

To establish a police station, &c. ;

(l) To compel boot-blacks to take out a license from the council and make them pay not more than five dollars annually for such license ; to prevent such persons from plying their trade in the streets, roads and public places.

To require boot-blacks to take a license, &c.

**2.** This act shall come into force on the day of its sanction.
