

CHAP. 96

An Act to divide the municipality of the parish of Ste. Thècle, in the county of Champlain, in two distinct and separate municipalities and to erect the municipality of the village of Ste. Thècle

[Assented to 27th April, 1909]

Preamble.

WHEREAS Messrs. E. Jannelle, George C. Kemp, O. Desaulniers, Achille Gervais, Joseph Bordeleau, Ludger Lapointe, Alphonse Beaudet, J. A. Frigon and several other rate-payers, being proprietors, of the parish of Ste. Thècle, in the county of Champlain, forming more than two-thirds of the rate-payers and inhabitants of that part of the municipality of Ste. Thècle whose division and erection into a separate municipality are asked for, under the name of "The Municipality of the Village of Ste. Thècle," have prayed that, for their greater advantage, an act be passed to divide the municipality of the parish of Ste. Thècle in the said county and to erect a new, distinct and separate village municipality under the name of "The Municipality of the village of Ste. Thècle," and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Ste. Thècle, divided into two municipalities.

1. From and after the sanction of this act, the municipality of the parish of Ste. Thècle, county of Champlain, shall be divided into two separate municipalities for municipal purposes only, the first keeping the name of "The Municipality of the parish of Ste. Thècle" and the second taking the name of "The Municipality of the village of Ste. Thècle."

Boundaries of village of Ste. Thècle.

2. The municipality of the village of Ste. Thècle shall comprise part of the immoveables designated in the official plan and book of reference of the parish of Ste. Thècle under the numbers 83, 84, 85 and 86, and shall be bounded as follows:

On the southwest and south by the line of division between numbers 82 and 83 of the said cadastre, extending from the line of the Canadian Northern Quebec Railway to lake Chicot; on the north-west and on the north by the north shore of lake Chicot as far as the division line 84 and 85, from thence running towards the north round the land belonging to the *fabrique* of Sainte Thècle to the public highway; from thence crossing in an oblique line the public highway to the north-west line of lot number 85-2 following the said line as far as lot 86 and its prolongation to the public highway at its intersec-

tion with the line between numbers 86 and 87; on the north-east by the said division line between the numbers 86 and 87 as far as the Canadian Northern Quebec Railway; on the south-east by the line of the said railway as far as the division line between lots numbers 82 and 83 of the above mentioned cadastre.

3. The municipality of the village of Ste. Thècle shall be governed by the provisions of the Municipal Code except where the same are expressly derogated from by this act or by the inconsistent provisions it may contain. Municipal Code to apply.

4. The first election of councillors for the municipality shall take place in the month following the sanction of this act and all the articles of the Municipal Code relating to elections and meetings of municipal electors shall apply to the said election *mutatis mutandis*. First election of councillors.

5. For the election mentioned in the foregoing article, the valuation roll of the municipality of the parish of Ste. Thècle then in force shall serve as a basis for the qualification of the municipal electors. Who to vote thereat.

6. Within the month following the sanction of this act, the municipal electors of the parish of Ste. Thècle shall elect, in accordance with the provisions of the Municipal Code, councillors to replace those who shall not be qualified owing to the passing of this act. When first council for parish to be elected, &c.

7. The cost of this act shall be paid by the municipality of the village of Ste. Thècle. Costs of this act.

8. This act shall come into force on the day of its sanction. Coming into force.
