

## CHAP. 129

An Act to amend the act 3 Edward VII, chapter 101, granting certain powers to the New Richmond Lumber Company, Limited

[Assented to 7th May, 1909]

Preamble.

**W**HEREAS the New Richmond Lumber Company, Limited, incorporated by letters patent issued on the fourteenth of December, 1895, under the great seal of the Dominion of Canada, has, by petition, represented that it has sold and conveyed to the Cascapedia Manufacturing and Trading Company, all its rights and property on the Little Cascapedia River including a timber limit of twelve hundred square miles, and that the said Cascapedia Manufacturing and Trading Company has been incorporated, (by Federal charter), for the sole purpose of developing the property of the New Richmond Lumber Company, and that it is absolutely necessary for the development of the said limit that the said Cascapedia Manufacturing and Trading Company should acquire the rights granted to the New Richmond Lumber Company, by the act 3 Edward VII, chapter 101, and that it is expedient that the said limit should be so developed ;

And whereas it is expedient to grant the prayer contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

3 Ed. VII, c. 101, s. 2a, amended. **1.** The following section is added after section 2 of the act 3 Edward VII, chapter 101 :

Transfer of powers of company.

“**2a.** The New Richmond Lumber Company, Limited, shall have full power and authority to transfer, sell and convey to the Cascapedia Manufacturing and Trading Company the powers by this act granted to the said New Richmond Lumber Company, Limited.”

2 Ed. VII, c. 85, s. 5, replaced. **2.** Section 5 of the act 2 Edward VII, chapter 85, as amended by the act 3 Edward VII, chapter 101, section 1, is replaced by the following :

Leasing, &c., of surplus water.

Certain expropriation authorized.

“**5.** The company may lease or sell the surplus water belonging to it which it cannot use or dispose of.

The New Richmond Lumber Company, Limited, is authorized to expropriate, on the Little Cascapedia River beginning at the mouth of the said river on cadastral lot number 147 of the 1st range of the township of New Richmond and its tributaries, such land adjacent to, or connected with the works

of the company or that may be flooded or affected by the erection of the company's dams, works and buildings. Such expropriation shall be made in conformity with the provisions of the Revised Statutes respecting railways.

**3.** This act shall come into force on the day of its sanction. Coming into force.

## CHAP. 130

An Act to amend the act incorporating the Association of Opticians of the Province of Quebec

[Assented to 27th April, 1909]

**W**HEREAS the Association of Opticians of the Province Preamble.  
of Quebec has, by petition, represented that it is expedient to amend its charter, the act 6 Edward VII, chapter 89, so as to define more clearly its rights and obligations, and whereas it is expedient to grant the prayer to that effect contained in the said petition :

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Section 2 of chapter 89, of the act 6 Edward VII, 6 Ed. VII, c. 89, s. 2, replaced.  
is replaced by the following :

**"2.** The corporation, in addition to the present members Membership of corporation.  
of the Association of Opticians of the Province of Quebec, shall consist of all such persons as now are or who have been opticians upon their own account previously to the passing of this act, and who have been examined in such manner and upon such subjects as the council of the corporation may deem expedient, or who have received certificates of competence for admission to membership, and all such members shall contribute to the funds of the corporation as shall be provided by its by-laws.

**"2a.** It shall be unlawful for any person to practice optometry in this Province unless he has first obtained a certificate of registration and license from the council of this association." License to practice optometry, &c.

**"2b.** Any person who is engaged in the practice of optometry in this Province on or before the date of the passing of this act shall be entitled to a license, without examination, provided written application shall be made therefor within Certain persons entitled to license without examination.
