

CHAP. 132

An Act to incorporate *La ligue anti-alcoolique de Québec*

[Assented to 7th May, 1909]

Preamble.

WHEREAS Sir François Langelier, acting Chief Justice of the Superior Court ; Honourable J. Sharples, Legislative Councillor ; Dr D. Brochu, medical superintendent of Beauport asylum ; P. B. Dumoulin, manager of Molson's Bank ; Dr C. R. Paquin ; Edm. Rousseau, author ; Sir J. Geo. Garneau, mayor of Québec ; Honourable A. B. Routhier, late acting Chief Justice of the Superior Court ; Honourable F. X. Lemieux, judge of the Superior Court ; Honourable Charles Langelier, sheriff of Québec ; Honourable P. A. Choquette, Senator ; Honourable L. P. Pelletier, advocate ; Honourable E. J. Flynn, advocate ; Art. Lachance, M. P. ; Jos. Turcotte, M. P. ; Honourable P. Boucher de la Bruère ; Honourable Thomas Chapais, Legislative Councillor ; A. Jobin, physician ; J. C. Magnan teacher ; Honourable A. Turgeon, Legislative Councillor ; Honourable P. Landry, Senator and Jean Dumont, journalist, have, by their petition, represented that they wish to establish an association with the object of contending against the abuse of alcoholic liquors and against the progress of alcoholism and have for such purpose prayed to be incorporated under the name of "*La ligue anti-alcoolique de Québec.*"

And whereas such an association would be one of public utility, and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Québec, enacts as follows :

Persons incorporated.

1. The persons above mentioned, together with all others who may join them and become members of the association under such by-laws as it may make, are incorporated under the name of "*La ligue anti-alcoolique de Québec*", hereinafter called "The League", with the objects mentioned in the preamble.

Name.

Corporate seat.

2. The corporate seat of the league shall be in Québec.

Powers.

3. The league shall have all the powers and rights which belong to civil and commercial corporations, including that of holding, acquiring, hypothecating and alienating immoveables, the value whereof shall not exceed twenty-five thousand dollars.

Means of action.

4. The means of action of the league shall be :
Propagandism by word of mouth (courses and lectures)

Propagandism by writings.

Temperance works.

All legal means for contending against alcoholism and among others : laying information through one of its secretaries with the collector of provincial revenue, of any offence against the license law.

5. The league may consist :

Sections, &c.

- a. Of a central section ;
- b. Of local sections ;
- c. Of affiliated or associated sections ;
- d. Of isolated members.

6. The seat of the central section shall be in Quebec, at the corporate seat of the league whereof it shall be the nucleus ; it shall pass by-laws, establish the amount of the contributions and adopt regulations for its internal government, as well as those it may deem advisable to apply to the local sections and affiliated or associated societies. Its officers shall be those of the general board.

Seat of central section.

Powers of said section.

7. The local sections shall be under the direction of the central section in accordance with such by-laws as the latter may adopt.

Direction of local sections.

8. Every person approved by the general council may have himself inscribed directly at the central section as an isolated member ; every person belonging to a temperance society shall be *ex officio* a member of the league on condition that he apply therefor.

Isolated and *ex officio* members.

9. The society shall be managed free of charge by a general council consisting of a president, a first vice-president, two assistant vice-presidents, a general secretary, two assistant secretaries, a treasurer and six general councillors and a councillor delegated by each of the local sections.

General council.

10. The members of the council shall be appointed by the general meeting of the members of the league, to be held annually and it may also elect honorary officers.

Members of council how appointed, &c.

11. The resources of the league shall consist of the property and revenues of all kinds belonging to it and all the proceeds of :

Resources of league.

1. The annual contributions ;
2. All gifts and legacies made to it ;
3. All subsidies that may be granted it ;
4. The receipts which may be realized by means of its action.

By-laws of
council.

12. The council shall have power to make by-laws for the carrying out of this act and for regulating the organization of the society and of its sections, its works and its management, the admission and exclusion of members, the amount and method of payment of assessments, the meetings and sessions, the management and disposal of property, the powers and duties of the officers and all other matters on which it may be necessary to make by-laws.

Statement
to Lieuten-
ant Governor
in Council.

13. The corporation shall transmit to the Lieutenant-Governor in Council, whenever thereunto required by the Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and by-laws.

Coming into
force.

14. This act shall come into force on the day of its sanction.

CHAP. 133

An Act to incorporate "The Montreal Tuberculosis Institute"

[Assented to 27th April, 1909]

Preamble.

WHEREAS Sir George A. Drummond, Jeffrey H. Burland, Clarissa J. Ami, Henrietta R. Cathagne, James W. Pyke, Richard B. Angus, Honourable Louis Beaubien, Charles Hosmer, Thomas Labatt, Thos. Roddick, M.D.; E. P. Lachapelle, M.D.; Charles M. Holt, K.C.; Honourable F. L. Beique, Honourable L. J. Forget, J. G. Adami, M.D.; Robt. Archer, H. D. Blackadder, M.D.; E. J. C. Kennedy, M.D.; Honourable Jas. J. Guerin, M.D.; E. Harding, M.D.; J. C. Holden, Margaret Learmont, Jessie Dow, Mary Dow, C. Ida McCarthy, M. Davis, David Morrice, H. Southam, C. P. Howard, M.D.; L. Joseph Lemieux, M.D.; W. F. Hamilton, M.D.; E. G. Dagenais, M.D. and Louis Laberge, M.D., all of the city and district of Montreal, have, by their petition, prayed to be incorporated as an institute for the prevention and the cure of tuberculosis, and whereas it is advisable to incorporate the said institute under the name of the Montreal Tuberculosis Institute;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Persons in-
corporated.

1. The several persons hereinbefore named, and all other persons who now are or who may hereafter be associated with them for the purposes of this act are constituted a body politic
