CHAP. 135

An Act to incorporate The Shawinigan Falls' General Hospital

[Assented to 7th May, 1909]

Preamble.

WHEREAS a petition has been presented by Vivian Burrill, H. Biermans, A. E. Paquette, advocate, all of the town of Shawinigan Falls, in the Province of Quebec, and P. H. Falter and J. E. Aldred, both of the city of Montreal, said Province, representing that it is expedient that there should be founded at the town of Shawinigan Falls a hospital for the care and treatment of sick and injured persons without any distinction of creed, race or nationality, and that such an institution is greatly needed in the said locality, and that the incorporators have raised an amount of ten thousand dollars to form the nucleus of the fund necessary to establish the said hospital, and that it is expedient that they and their successors be incorporated under the name of "The Shawinigan Falls General Hospital", with the powers hereinafter mentioned; and whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Persons in-
corporated.

1. The said Vivian Burrill, H. Biermans, A. E. Paquette, P. H. Falter and J. E. Aldred, together with such persons as are or may hereafter be associated with them, are hereby

incorporated under the name of "Shawinigan Falls' General Hospital" with power to establish a hospital at the town of Shawinigan Fall in the Province of Quebec, to be called the "Shawinigan Falls' General Hospital", and also to acquire

Powers, &c.

by purchase, donation, devise, bequest or otherwise, such real estate, money or securities as are requisite for the purposes of such hospital, and of providing the revenue therefor; provided, however, that the annual value of the real estate owned by the said corporation and held for revenue purposes only,

at one time, shall not exceed the sum of twenty-five thousand dollars.

2. There shall be eight governors of the said corporation, ^{Governors,} namely : the five incorporators hereinabove mentioned, who ^{&c.} shall add to their number three more by election or appointment; and five members of the said board shall constitute a quorum thereof.

3. The governors of the said hospital and their successors ^{Powers of} in office shall, subject to the provisions of this act, have the ^{governors.} power from time to time to make and from time to time to amend the by-laws, rules and regulations for the management and good government of the hospital, and of all its property and financial affairs ; to adopt a common seal ; to provide for and regulate the forms of proceedings incidental to the election of governors thereof, and the meetings and order of proceedings of the governors ; the internal and external management of the hospital, including all matters and things incidental thereto and necessary and expedient for the management and use thereof, as well as in respect of the officials and surgical and medical attendants thereof, as of the patients admitted therein, and the terms and conditions of the reception, treatment and dismissal of the patients ; the conduct and management of any dispensary therein or connected therewith, or under the control of the corporation thereof ; the appointment of all officials, internal and external, and the regulation of their powers, duties and obligations to the corporation ; the attendance upon the said hospital and the patients thereof, by the members of medical or other scientific or educational bodies or faculties ; the attendance and discipline of sick and hospital nurses, and their effective education and training as such for professional and other purposes ; and finally, to provide for and regulate all matters and things falling within the powers of the said corporation, except as to matters and things for which provision is made in this act.

4. The office of governor shall become vacant by insanity, ^{Vacancies in} or other mental incapacity of the holder thereof, his insolvency, ^{office of} bankruptcy or conviction of any offence against the criminal ^{governor, &c.} law ; and upon the occurring of any vacancy, the remaining governors, acting as a board, shall forthwith appoint a governor to fill the vacancy.

5. The said hospital is so hereby incorporated for the ^{Objects of} reception and treatment of sick and injured persons of all ^{corporation,} races and creeds without distinction ; and ^{&c.} provision shall be made in the by-laws for the attendance, as far as practicable, without interfering with medical or surgical treatment, upon

patients in the hospital of all creeds, by the ministers of religion of such creeds, respectively, upon terms of absolute equality as to all such ministers of all creeds and churches, and as shall be provided by the by-laws.

6. The corporation may with the consent of the Lieutenant Governor in Council and after notice published in the *Quebec Official Gazette*, make arrangements with any other hospital corporation for the acquisition thereof, or for the amalgamation therewith and under the name of the corporation hereby created, or such other name as in the premises may seem desirable.

CHAP. 136

An Act to incorporate St. Anthony's Guild

[Assented to 27th April, 1909]

Preamble.

WHEREAS the persons hereinafter mentioned have, by petition, prayed for incorporation under the name of "St. Anthony's Guild", and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Persons
incorporated.

1. Misses Johanna Malone, Annie Watters, Annie Fox, Helen Gillespie and Elizabeth Webb, all of the city and district of Montreal, and such other persons as now are or may become associated with them under the authority of this act, are constituted a body corporate and politic under the name of "St. Anthony's Guild".

Name.

Powers.

2. The corporation shall, under such name, have and exercise all the powers, privileges, rights and immunities of corporations legally constituted.
