## CHAP. 136

### An Act to incorporate St. Anthony's Guild

[Assented to 27th April, 1909]

Preamble.

**W**HEREAS the persons hereinafter mentioned have, by petition, prayed for incorporation under the name of "St. Anthony's Guild", and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Persons  
incorporated.

**1.** Misses Johanna Malone, Annie Watters, Annie Fox, Helen Gillespie and Elizabeth Webb, all of the city and district of Montreal, and such other persons as now are or may become associated with them under the authority of this act, are constituted a body corporate and politic under the name of

Name.

"St. Anthony's Guild".

Powers.

**2.** The corporation shall, under such name, have and exercise all the powers, privileges, rights and immunities of corporations legally constituted.

**3.** The object of the corporation is to unite fraternally its members in order to carry out any good work or undertaking of the society and specially to provide for its members every moral and material aid possible, and to furnish help to the English speaking Catholic sick, poor and abandoned, according to its by-laws. Objects.

**4.** The society shall be managed by a council of administration composed of a lady president, a secretary and a treasurer, and such others as may be hereafter deemed necessary, and such officers shall be elected as provided by the society's by-laws. Council of administration.

**5.** The council may adopt, modify, annul or make any rules and regulations which it may deem necessary or useful for the government of its members or property. Powers of council.

**6.** The society shall have the privilege of having a spiritual director named by the Ordinary of the diocese. Spiritual director.

**7.** The principal seat of the society shall be in Montreal. Place of business.

**8.** The society may acquire moveable and immoveable property, by gift or otherwise, provided that the annual revenue does not exceed twenty thousand dollars; it may acquire, lease, alienate, borrow, hypothecate, act and contract in any manner, provided the acts shall be in conformity with the by-laws of the society and laws of the Province. Acquisition, &c., of property, &c.

**9.** The society shall have perpetual succession ; it shall have the right to a common seal which it may change at pleasure. Perpetual succession, &c.

**10.** The society may select an attorney, a physician and any other persons it may deem necessary to associate with it for the welfare of the society. Appointment of attorney, &c.

**11.** Members of the society shall be admitted by the majority of the council, with the consent of the spiritual director. Admission of members.

**12.** All acquisitions, gifts and other revenues shall form a common fund which shall never be alienated from the objects of the society. Property, &c., to form common fund, &c.

**13.** The members of the society, personally, shall have no right or claim whatsoever upon the property of the society, nor shall they be liable in any manner for its obligations. Members not interested in property, &c.

**14.** In case of extinction of the society, the members or Disposal of

property on winding up. their heirs shall receive the amount donated by them, subject to the by-laws, and any surplus remaining shall be distributed by the council in any manner and to whoever they think proper.

Services of members gratuitous. **15.** The members of the society shall not be entitled to any wages, payment, interest or compensation for their services, except, however, the ordinary maintenance allowed every member in accordance with the by-laws of the society.

Who represent corporation. **16.** In all civil matters, the president and the secretary of the council, duly authorized by a resolution of the board, shall represent the corporation.

By-laws. **17.** The council shall have the right to make by-laws for the execution of the powers conferred on it and the society by this act, provided such by-laws be not contrary to the laws of this Province.

Council. **18.** The council shall be composed of the said Miss Malone, as president, the said Miss Watters as treasurer, and the said Miss Fox as secretary, who shall be provisional officers until replaced, according to this act and the by-laws of the society.

Statement to L.-G. in Council. **19.** The corporation shall transmit to the Lieutenant-Governor in Council, whenever required so to do by the Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and regulations.

## CHAP. 137

An Act to amend the act 7 Edward VII, chapter 116, respecting the building of a new church at St. Prime

[Assented to 7th May, 1909]

Preamble. **W**HEREAS the trustees of the parish of St. Prime have, by their petition, represented :

That the act passed the session before last of the Legislature presents in its application serious drawbacks which will necessitate unnecessary expense and formalities ;

That it is in the interests of the present and future freeholders of the said parish to adopt a more simple and more economical method in making the act of assessment and of
