2. The following section is inserted in the said act after section 13 :

Assessment upon certain students by faculties of certain university, &c.

" **13a.** Every faculty or school of Laval University, in Montreal or affiliated with the said university, may levy by resolution upon its students and collect from them for the benefit of *La Maison des Etudiants* a yearly assessment fixed by the by-laws of the corporation not exceeding five dollars or may order that the yearly assessment imposed by *La Maison des Etudiants* on its members, shall be collected by the treasurer of each of the said faculties or schools and that the payment thereof shall be obligatory for every student in the same manner as the payment for lectures or other dues imposed on the students following the course of any of the said faculties or schools and as if such assessment had been imposed by them and for them.

Assessment of students by administrators, &c.

The administrators of the said university may also by resolution impose the said assessment and exact the payment thereof from any student attending any of the schools or faculties of the said university, for the benefit of the corporation. The assessment already imposed in certain of the said faculties or schools and the collection thereof, are declared to have been legally affected, to all intents and purposes.

Coming into force.

3. This act shall come into force on the day of its sanction.

CHAP. 144

An Act to incorporate *La Corporation agricole et industrielle des missionnaires du Saint Esprit*

[Assented to 27th April, 1909]

Preamble.

WHEREAS the Reverend Fathers Henri Vanhaecke, Albert David, Joseph Dumont and Charles Démaison, all members of *La Congrégation du Saint Esprit*, now residing at St. Alexandre de la Gatineau, in the township of Hull, county of Ottawa, have, by their petition, represented :

That they have founded an establishment of their order at St. Alexandre de la Gatineau and that their object is :
(a) To devote themselves to agriculture and teach the same by theory and practice ; (b) to encourage and develop coloniza-

tion by means of schools for disseminating scientific knowledge and the knowledge of practical agriculture ; (c) to establish missions with the object of giving lectures to the public on religious instruction and on agricultural and industrial sciences ; (d) to establish orphan asylums where the aforesaid sciences will be taught to the inmates to enable them to learn trades or devote themselves to agriculture and industry and become useful members of society ; (e) to establish industrial schools where young men may learn mechanical and industrial arts and agriculture ;

That His Grace, the Archbishop of Ottawa, approves the petitioners' application for an act of incorporation ;

Whereas they have, by their petition prayed to be constituted a corporation and it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The said Fathers Henri Vanhaecke, Albert David, Joseph Persons incorporated. Dumont and Charles Demaison and the persons who may join or succeed them under the constitution and by-laws of the said *Congrégation du Saint Esprit*, are incorporated under the name of *La Corporation agricole et industrielle des missionnaires du Saint Esprit*. Name.

2. The corporation may :

1. Establish and maintain boarding and day schools for religious, industrial and agricultural instruction ; Objects.

2. Teach young men agricultural and industrial arts, and, for the purpose of such teaching, establish, maintain and operate model farms, butter and cheese factories, grist-mills, saw-mills, and works for producing electricity ;

3. Erect all buildings suitable for the above purposes ;

4. Do everything necessary for the fulfilment of the objects aforesaid and all other things not contrary to law and authorized by the rules of the corporation of the community.

3. The corporation hereby constituted shall have perpetual succession. Perpetual succession.

It may have a common seal which it may alter at will, sue and be sued, borrow, sign bills of exchange and promissory notes, hold, accept and acquire by any legal title moveable and immoveable property which it may sell, convey, lease, transfer, exchange or otherwise dispose of by any title whatsoever, provided always that the value of the immoveable property held shall not exceed two hundred and fifty thousand dollars Common seal; powers to ester en justice, acquire property, &c.

according to the municipal valuation. The said corporation may also hypothecate its immoveables.

By-laws **4.** The corporation may make, amend and repeal, regulations and by-laws, not contrary to law, which it may deem useful or necessary for its interests and government.

Procurators. **5.** One or more procurators may be appointed for the transaction of business.

Vault or cemetery.
Proviso. **6.** The corporation may have a vault or cemetery on its property for the burial of the mortal remains of its members, provided it complies with the laws, prescriptions and regulations enacted with reference to such matter.

Corporate seat. **7.** The corporate seat of the corporation shall be at St. Alexandre de la Gatineau, in the township of Hull, in the county of Ottawa.

Report to Lieut.-Gov. in Council. **8.** The corporation shall, when required so to do by the Provincial Secretary, transmit to the Lieutenant-Governor in Council, a detailed statement of its property, the names of its officers and agents, and a certified copy of its rules and regulations.

Coming into force. **9.** This act shall come into force on the day of its sanction.

CHAP. 145

An Act respecting The Ottawa Golf Club

[Assented to 27th April, 1909]

Preamble. **W**HEREAS, The Ottawa Golf Club has presented a petition, praying that its charter as contained in the Act 7 Edward VII, chapter 131, be amended as hereinafter set forth and it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
