CHAP. 146

An Act to incorporate "*L'Association de l'Arsenal du 65ième Régiment C.M.R.*"

[Assented to 7th May, 1909]

WHEREAS Lieutenant-Colonel Alfred E. Labelle, Major Preamble. Léonard G. de Tonnancour, Major Ernest J. Peltier, and the officers of the 65th regiment of the Militia of Canada, known as "*Carabiniers Mont-Royal*", of Canada, have, by their petition, represented that they wish to be incorporated as an association for the purpose of owning and maintaining a regimental armoury in the city of Montreal, and for other regimental purposes, and that it be enacted as hereinafter set forth ; and whereas it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Lieutenant-Colonel Alfred E. Labelle, Major Léonard G. Persons in- de Tonnancour, Major Ernest J. Peltier, all of the city of corporated. Montreal, and the other active commissioned officers, either present or future, of the 65th regiment of the Militia of Canada, now known as "*Carabiniers Mont-Royal*", are incorporated under the name of "*L'Association de l'Arsenal du 65ième* Name. *Régiment C.M.R.*", hereinafter called "*the Association*".

2. The said Lieutenant-Colonel Alfred E. Labelle, Major Provisional Léonard G. de Tonnancour, and Major Ernest J. Peltier, shall be committee. the first or provisional committee of the association, and shall continue in office until replaced by a committee elected according to the by-laws of the association.

3. The head office of the association shall be in the city of Head office Montreal, in the Province of Quebec.

4. The first general meeting of the association for organiza- First general tion, the passing of by-laws and other business, shall be held meeting.

at the city of Montreal at such time and place as the provisional committee shall determine.

Powers of certain committees and persons.

5. The provisional committee, the committee elected according to the by-laws, and the officers of the association, may exercise any or all of the powers of the association, as may be provided by by-law, from time to time.

Objects.

6. The objects and powers of the association shall be :

(a) To own and maintain a regimental armoury for the purposes of said regiment in the city of Montreal, and to act generally in the interest of the regiment :

(b) To acquire immoveable property and mortgage, lease, sell and otherwise alienate the same, provided the value of such property held by the association at any one time shall not exceed the sum of three hundred thousand dollars ; and to acquire and dispose of such moveable property as the association may require ;

(c) To sue and be sued in any manner whatever ;

(d) To make by-laws, rules and regulations for the governing of the association and the carrying out of its objects ;

(e) To draw, accept and endorse bills of exchange, promissory notes and other negotiable instruments, under the hands of its officers or others, as may be determined by its committee.

Members not personally liable for debts.

7. No member of the association shall be personally liable for any of the debts thereof.

When officers to become and cease to be such.

8. For the purposes hereof, an active commissioned officer of the regiment shall become such on the date he is gazetted to the regiment, and shall cease to be such on the date he is gazetted out of the regiment either to the retired list, on the reserve or otherwise, except those who, according to the rules of the said association, will be appointed life members thereof.

Consequences of retirement, &c., of officers.

9. Every member retiring from or ceasing to be an active commissioned officer of the regiment shall *ipso facto* forfeit all rights of membership in the association and its property, except those who, according to the rules of the said association, are appointed life members.

Revenues how to be applied.

10. The revenues derived from the property of the association and all moneys borrowed on the security thereof, shall be the property of and employed for the exclusive use of the association and for the construction, repairing and furnishing of buildings and apartments required for its purposes.

CHAP. 147

An Act to incorporate the Montreal Jockey Club

[Assented to 29th May, 1909]

WHEREAS Sir Hugh Montagu Allan, the Honourable J. Preamble.
 E. Robidoux, the Honourable J. P. B. Casgrain, Hugh
 Paton, Hugh A. Allan, George R. Hooper, Colin Campbell,
 Charles McEachran, Bartlett McLennan, A. E. Ogilvie and
 Hartland B. McDougall, have, by their petition, represented:

That heretofore to wit on the second day of November, 1905,
 a company was incorporated under letters patent issued by
 the Secretary of State for Canada, under the name of the
 Montreal Jockey Club, Limited, of which Company, the said
 petitioners are directors ;

That the said company has acquired certain lands in the
 vicinity of Montreal, and has laid out thereon a race-course
 and has constructed divers buildings in connection therewith ;

That the object of the company is to hold race-meetings
 and exhibitions and that it is believed by the petitioners that
 it would be to the advantage of the persons interested and
 of the Province generally that the operations of the company
 should be confined to the Province and that a new organ-
 ization should be created under provincial laws with power
 to acquire the property of the said company and to assume
 its debts and obligations ;

And whereas it is expedient to grant the prayer of the said
 petitioners ;

Therefore, His Majesty, with the advice and consent of the
 Legislative Council and of the Legislative Assembly of Quebec,
 enacts as follows :
