

inconsistent with the law or this act, shall be binding upon the club and upon its members.

No gambling on club premises. Proviso. **13.** The club shall not permit any form of gambling to be carried on upon its premises ; but this shall not affect wagers upon exercises for promoting skill in the use of arms or upon horse or foot races or other lawful games requiring bodily activity or address within the meaning of the Civil Code.

Selling of intoxicating liquors. **14.** Upon obtaining a club license the club shall have the right to sell intoxicating liquors in the club-house and during meetings and exhibitions, also in the grand stand to the public. Such license may be obtained and granted under the terms of paragraph 2 of article 46 of the Quebec License Law.

Coming into force. **15.** This act shall come into force on the day of its sanction.

#### CHAP. 148

An Act to authorize Jules Napoléon Hamel and Berthe Alphonsine Eugénie Boyer to adopt Elizabeth Hulda Vankoughnet

[Assented to 7th May, 1909]

Preamble.

**W**HEREAS Jules Napoléon Hamel, of Montreal, and Dame Berthe Alphonsine Eugénie Boyer, his wife, have by their petition represented that they are desirous of adopting as their child Elizabeth Hulda Vankoughnet, daughter of George Macaulay Diehl Vankoughnet, of Toronto, in the Province of Ontario, by his marriage with the late Dame Marie Larsen, and that the said George Macaulay Diehl Vankoughnet has consented to such adoption, and that the said parties have arranged for the passing of an act to give effect to such adoption by the Legislatures of the provinces of Quebec and Ontario, the domicile of the petitioners being in the Province of Quebec, and the domicile of George Macaulay Diehl Vankoughnet being in the Province of Ontario.

Whereas the Legislature of the said Province of Ontario has passed an act, to wit : 9 Edward VII, chapter 165, on the petition of George Macaulay Diehl Vankoughnet, authorizing and confirming the deed of adoption as contained in the schedule to this act ;

Whereas it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Jules Napoléon Hamel, of Montreal, and Dame Berthe J. N. Hamel and wife authorized to adopt certain child, &c.  
Alphonsine Eugénie Boyer, his wife, are hereby authorized to enter into an agreement in the form set out in the schedule to this act, and from and after the execution of said agreement by the parties thereto and the passing of an act by the Legislature of the Province of Ontario authorizing or confirming the said agreement, the said agreement shall be and is hereby confirmed and declared valid and binding in so far as such confirmation and declaration by this Legislature are required.

2. This act shall come into force on the day of its sanction. Coming into force.

#### SCHEDULE A

This indenture made the \_\_\_\_\_ day of nineteen hundred and nine, between George Macaulay Diehl Vankoughnet, of the city of Toronto, in the Province of Ontario, (hereinafter called the parent), and Jules Napoléon Hamel and Berthe Alphonsine Eugénie Boyer, his wife, both of the city of Montreal, in the Province of Quebec, (hereinafter called the adopting parties) ;

Whereas the adopting parties have no child of their own, and are desirous of adopting a child to be brought up and educated by them ;

And whereas the parent has an infant daughter born on the \_\_\_\_\_ day of July, nineteen hundred and five to wit, Elizabeth Hulda Vankoughnet ;

And whereas the mother of the said child died on the nineteenth day of July nineteen hundred and eight ;

And whereas by reason of the exigencies of his employment, the parent is not at present, nor is he likely in the future to be in a position to provide for the said Elizabeth Hulda Vankoughnet a permanent home and home life ;

And whereas the parent is satisfied that the adopting parties are fit and proper persons to have the custody of the said child, and that the arrangements hereinafter set forth would be for the benefit of the said child, and has agreed to permit the said child to be adopted by the adopting parties upon the terms hereinafter contained. Now, therefore, this indenture witnesseth, and it is hereby agreed and declared as follows :

1. The parent consents to the adoption of the said child, Elizabeth Hulda Vankoughnet, by the adopting parties, and

hereby relinquishes in their favour all his rights, claims and authority as the father of the said child.

2. (a) The said adopting parties shall have the same rights and authority over the said child, and shall be held to the same duties towards her, as if she was their lawful child.

(b) In construing the provisions of any wills, contracts or settlements heretofore executed in which the lawful child or children of the said adopting parties are mentioned as beneficiaries or otherwise, the said child shall not be deemed to be a child of the said Jules Napoléon Hamel and Berthe Alphonsine Eugénie Boyer, his wife, unless she is mentioned therein by name.

3. The adopting parties undertake at their own expense to give the said child a thoroughly good education suitable to their own rank in life, and at all times during her infancy properly to maintain her, and furnish her with all things necessary and suitable for a person of her age in such rank as aforesaid.

#### CHAP. 149

An Act to amend the act 38 Victoria, chapter 94, respecting the estate of the late Stanley C. Bagg

[Assented to 29th May, 1909]

**Preamble.**

**W**HEREAS Dame Catherine Mitcheson, of the city and district of Montreal, widow of the late Stanley Clark Bagg, in his lifetime of the said city and district, gentleman, and Robert Stanley Bagg, Esquire, advocate, of the said city and district, have, by their petition, represented :

That the said Dame Catherine Mitcheson and the said Robert Stanley Bagg are the sole surviving executors of the said late S. C. Bagg ;

That the said Dame Catherine Mitcheson is, under the terms of the said will, the universal usufructuary legatee of all the property, moveable and immoveable, constituting the said succession and estate ;

That the said Robert Stanley Bagg was on the 12th day of August, 1894, duly named by the Superior Court for the district of Montreal, curator to the substitution created under the terms of the said last will of the said S. C. Bagg ;
