

the name of Bois Brillant and situate in the parish of St. Foye, county of Quebec, consisting of lots Nos 162, 167, 169 and part of lot 166 of the official cadastre of the said parish left by the late Mrs Lesage—is authorized provided the moneys derived from such sale be re-invested according to the provisions of the Civil Code on the advice of a family council and with the consent of the curator to the substitution, the latter to be a party to the contract of sale, and the acquittance given by the institute and substitutes on payment of the price of sale, of each of such immoveables, shall be good and valid without the purchaser being obliged to see to the investment of such price of sale. Re-investment of price of sale, &c.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 6 6

An Act respecting the estate of the late John Henry Wilson

[Assented to 7th May, 1909]

WHEREAS William Olier Wilson, merchant ; Wilfrid Preamble.

Meloche, accountant ; Elvina *alias* Albani Wilson, spinster, in their capacity of testamentary executors of the late John Henry Wilson, in his lifetime, hardware merchant, of the city of Montreal, the said William Olier Wilson, the said Elvina *alias* Albani Wilson, Joseph Henri Wilson, clerk ; Henriette Wilson, widow of the late Donatien Rolland, ; Hortense Wilson, widow of the late Adolphe Brossard ; Blanche Wilson, wife of Emile Globensky, gentleman, and the latter for the purpose of authorizing his wife, and May-Adèle *alias* Mammy Wilson, wife of Arthur Benoit, civic employee, and the latter for the purpose of authorizing his wife, all of the city of Montreal, have, by their petition, represented :

That by his will made at Montreal, before N. Pérodeau and colleague, notaries, on the twenty-fifth of January, 1900, the said late J. H. Wilson, after bequeathing certain special legacies, created a life rent of twenty dollars per month in favor of his two sisters, Flora and Louise Wilson, an annual life rent of three hundred and sixty dollars in favor of his sister-in-law, Mathilde Asselin, bequeathed the remainder and residue of all his moveable and immoveable property in full ownership to his children, born of his marriage with the late Elvina Asselin and appointed the said William Olier Wilson, Wilfrid Meloche and Elvina *alias* Albani Wilson his testamentary executors, and at the same time administrators of the property and affairs

of his estate, with power to act beyond the year and day until the complete execution of his will, ordering that a partition of the property belonging to his estate should not be effected and take place, and that his legatees should not receive their shares of his estate until the liquidation of the property and affairs of his business as a hardware merchant in Montreal should have been effected, and that it was his express will that his estate, through his testamentary executors, should continue such business in Montreal under the same name of J. H. Wilson for fifteen years from the first of January following his death, as well as the store he kept at Valleyfield, unless for unavoidable causes which he could not foresee, his testamentary executors should in consequence of the result of the yearly inventory of the business, find that the keeping up of such establishments or of either of them would be prejudicial to the estate, whereupon they might decide to keep either one or the other or even both of them, and he ordered that until the partition of such property be effected between his universal legatees, his estate should pay them by roots an annual rent or sum of five hundred dollars, payable by monthly payments, and chargeable to the general expenses of his estate, wishing, nevertheless, that such annual rent should be increased to six hundred dollars for each of his unmarried children who were legatees ;

That the said J. H. Wilson died on the seventh of February, 1901, and left seven children as legatees as to ownership under the terms of his will, to wit : the said William Olier, Joseph Henri, Elvina *alias* Albani, Henriette, Hortense, Blanche and May-Adèle *alias* Mammy Wilson ;

That after the death of the said late J. H. Wilson, his testamentary executors discontinued his business establishment at Valleyfield, but they have so far continued, and intend to continue his store or establishment at Montreal, during the period of time mentioned and in accordance with the terms of his said will ;

That since the testator's death, the business of his said shop or establishment at Montreal, kept by the said testamentary executors of the said late J. H. Wilson on account of his succession has been prosperous and the affairs have greatly increased ;

That out of the seven children, legatees of the late J. H. Wilson, six are married and are entitled to receive under the said will an annual rent of five hundred dollars, the unmarried daughter receiving until her marriage a rental of six hundred dollars and after her marriage of five hundred dollars until the partition of the said property ;

That the collective amount of the annual rents, payable both

to the children who are legatees of the said late J. H. Wilson and to his special legatees is four thousand two hundred dollars;

That the prosperous condition of the affairs of the said business, will permit the testamentary executors increasing to the amount of five hundred dollars for each child, the annual rent payable to them under the terms of the will of the said late J. H. Wilson until the partition of his property ;

That the said testamentary executors are of opinion that such increase of annual rent under the circumstances would be reasonable, that they have no objection and consider themselves justified in consenting to the payment of such increase of annual rent, payable to each of the children of the said late J. H. Wilson, and whereas it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The said testamentary executors of the said late J. H. Wilson are authorized to increase by four hundred dollars per annum, from the first of January last—provided that the revenues of the succession, after payment of all expenses of administration are sufficient to make such payment—the annual rent payable to the children of the said late J. H. Wilson, until the partition of his property, under the terms of his said will, made before N. Pérodeau and colleague, notaries, on the twenty-fifth of January, 1900. Executors of J. H. Wilson authorized to increase certain allowance.

2. This act shall come into force one day of its sanction. Coming into force.

CHAP. 167

An Act to authorize the Bar of the Province of Quebec to admit F. O. Callaghan among its members, after examination

WHEREAS F. O. Callaghan, has, by his petition, represented : Preamble.
