That he has been in regular attendance at the office of Messrs Heneker and Duff, advocates, of the city and district of Montreal for the past three years without indenture;

That through his studies and experience he possesses all the necessary knowledge and qualifications for a practising advocate, and that he is qualified to practise as such as appears by certificate of his patrons;

That the General Council of the Bar of the Province of Quebec, has unanimously approved the passing of an act to admit him as one of its members after examination;

Whereas the petitioner has prayed for the passing of such an act, and it is expedient to grant the prayer contained in his petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows :

Bar of P. Q. authorized to admit F. O. Callaghan after examination, &c. **1.** The Bar of the Province of Quebec, is authorized to admit F. O. Callaghan, among its members after final examination and after he shall have paid the fees for admission to study and to practice.

Coming into force. **2.** This act shall come into force on the day of its sanction.

## CHAP. 168

An Act to authorize the Bar of the Province of Quebec to admit Edward A. O'Callaghan among its members, after examination

[Assented to 27th April, 1909]

Preamble. **W**HEREAS, Edward A. O'Callaghan, of the parish of, St. Ferdinand d'Halifax in the district of Arthabaska, has, by his petition, represented that he is a Bachelor of Arts of Manhattan College in the city of New York, and a Bachelor of Laws of the New York Law School, and that he is an attorney-at-law in good standing of the State of New Jersey, one of the United States of America, and has been such since February, 1897, and that he is an attorney and counselor at law in good standing of the State of New York, one of the United States of America, and has been such since the nineteenth day of April, 1905 ; and that he is desirous of being admitted as a member of the Bar of the Province of Quebec,

after such examination as the said Bar shall see fit to require, and

Whereas the General Council of the Bar of the Province of Quebec, on the fourteenth day of December, 1907, approved the petitioner's application, and

Whereas the petitioner has prayed for the passing of an act for the purposes hereinbelow mentioned, and it is expedient that said petition be granted ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows .

1. The Bar of the Province of Quebec is hereby authorized to admit the said Edward A. O'Callaghan among its members after he shall have passed the ordinary and regular examinations of said Bar for admission to the practice of law in the Province of Quebec.

Bar of P. Q. authorized to admit E. A. O'Callaghan after examination.

2. This act shall come into force on the day of its sanction.

## CHAP. 169

An Act to amend the act authorizing the Bar of the Province of Quebec, to admit Joseph Adelard Provencher among its members, after examination

[Assented to 29th May, 1909]

**W**HEREAS Joseph Adelard Provencher has, by his petition, represented :

That under the act 3 Edward VII, chapter 139, the Bar of the Province of Quebec was authorized to admit Joseph Adelard Provencher among its members, after final examination ;

That he has been deputy-prothonotary of the Superior Court and assistant clerk of the Circuit Court, for the district of Three Rivers, for the last twelve years, and that during such time he has acquired a knowledge of the law ;

That, after the passing of the said act, while continuing to exercise the judicial functions he then exercised and which he proposes to continue in future, he prepared to undergo such examination ;

That the notes and summaries which he prepared were destroyed in the fire at Three Rivers on the twenty-second of June last, and that, unless he abandons his present office, several years' labour will be required to replace them and to put him in a position to undergo such final examination ;
