Whereas the General Council of the Bar of the Province of Quebec, on the fourteenth day of December, 1907, approved the petitioner's application, and

Whereas the petitioner has prayed for the passing of an act for the purposes hereinbelow mentioned, and it is expedient that said petition be granted ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec enacts as follows .

1. The Bar of the Province of Quebec is hereby authorized to admit the said Edward A. O'Callaghan among its members after he shall have passed the ordinary and regular examinations of said Bar for admission to the practice of law in the Province of Quebec.

Bar of P. Q. authorized to admit E. A. O'Callaghan after examination.

2. This act shall come into force on the day of its sanction.

CHAP. 169

An Act to amend the act authorizing the Bar of the Province of Quebec, to admit Joseph Adelard Provencher among its members, after examination

[Assented to 29th May, 1909]

WHEREAS Joseph Adelard Provencher has, by his petition, represented :

That under the act 3 Edward VII, chapter 139, the Bar of the Province of Quebec was authorized to admit Joseph Adelard Provencher among its members, after final examination ;

That he has been deputy-prothonotary of the Superior Court and assistant clerk of the Circuit Court, for the district of Three Rivers, for the last twelve years, and that during such time he has acquired a knowledge of the law ;

That, after the passing of the said act, while continuing to exercise the judicial functions he then exercised and which he proposes to continue in future, he prepared to undergo such examination ;

That the notes and summaries which he prepared were destroyed in the fire at Three Rivers on the twenty-second of June last, and that, unless he abandons his present office, several years' labour will be required to replace them and to put him in a position to undergo such final examination ;

That the general council of the Bar of the Province of Quebec has given its consent to this act ;

Whereas the petitioner has prayed for the passing of an act for the purposes herein below mentioned, and it is expedient to grant the prayer contained in the petition ;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

 1. Section 1 of the act 3 Edward VII, chapter 139, is replaced by the following :

Bar of P. Q. authorized to admit J. A. Provencher after certain examination.
 “ 1. The Bar of the Province of Quebec, is authorized to admit Joseph Adelard Provencher among its members after he has passed an oral examination on the Civil Code, the Code of Civil Procedure and the Criminal Code and after he has paid the students’ and practitioners’ fees.”

CHAP. 170

An Act to authorize the Board of Notaries of the Province of Quebec to admit Marie Joseph Olivier Parent to the practice of the notarial profession, after examination

[Assented to 27th April, 1909]

Preamble.

WHEREAS Marie Joseph Olivier Parent, notarial student, of Beauport, has, by his petition, represented :

That he followed a course of classical studies at the Quebec Seminary ;

That he obtained the degree of Bachelor of Letters in March 1908, after matriculating in sciences in June 1905 ;

That on the seventeenth of September, 1905, he entered Laval University for the purpose of following the law lectures and that he finished following them in June, 1908 ;

That on the first of August, 1905, he was indentured as a student to Cyrille F. Delage, Esquire, notary, of the city of Quebec ;

That since the date of the said indenture he has regularly attended his patron’s office ;

That he wishes to present himself for the examination for admission to the practice of the notarial profession in July, 1909, when he will have attended a notary’s office for four years and have followed the lectures at Laval University for three years ;

That he wishes to undergo his examination for admission to the practice of the notarial profession without having to produce
