

CHAP. 179

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Max Wiseman to the practice of medicine, surgery and obstetrics

[Assented to 27th April, 1909]

Preamble.

WHEREAS Max Wiseman, physician of the city of Montreal, has, by his petition, represented :

That on the eleventh of June, 1907, he obtained a diploma of Doctor of Medicine from Laval University, Montreal ;

That he began to follow the lectures of the medical faculty of the said university before having obtained his admission to study, which he obtained on the twenty-ninth of September, 1908, from the College of Physicians and Surgeons of the Province of Quebec ;

That he is qualified to practise medicine, but that he cannot obtain his license to practise until he has completed his four years of study as a medical student ;

That he has obtained the consent of the College of Physicians and Surgeons of the Province of Quebec, to the passing of an act to authorize the said College to grant him his license ;

And whereas he has prayed that an act be passed to that effect and it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts, as follows :

College of P. and S., authorized to admit M. Wiseman.

1. The College of Physicians and Surgeons of the Province of Quebec, is authorized to admit the said Max Wiseman among its members and to grant him the necessary license to practise medicine, surgery and obstetrics in this Province.

Coming into force.

2. This act shall come into force on the day of its sanction.

CHAP. 180

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Alexis Turgeon among its members, after examination

[Assented to 1st April, 1909]

Preamble.

WHEREAS Alexis Turgeon, of the city of Sorel, county of Richelieu, has by his petition represented ;

That he has worked for twenty-five years and is still working as a dentist's mechanic and has acquired considerable experience in dental surgery but has always neglected to get himself registered as a student ;

That he is now married and has nothing but the said profession with which to earn his livelihood and that of his family which would suffer considerably if he were obliged to pass the four years of studentship required by law and which, moreover, he could not do owing to his age ;

That he is at present attending the lectures of the school of dental surgery of Laval University, in Montreal ;

That the petitioner possesses all the theoretical and practical knowledge needed for the practice of dental surgery ;

That he is willing to pass the examinations for admission to the study and practice of the said profession ;

That the board of governors of the College of Dental Surgeons of the Province of Quebec, at its meeting held on the tenth of September, 1908, authorized the said petitioner to apply for the passing of this act, provided it contains the following clauses :

1. That the petitioner shall pass the examination for admission to study ;

2. That the petitioner shall follow one session's lectures of a school of dentistry ;

3. That he shall pass the examination for a license.

Whereas the petitioner has prayed for the passing of an act to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit Alexis Turgeon among its members and to grant him a license to practise the profession of surgeon dentist after the said Alexis Turgeon shall have followed one session's lectures of a school of dentistry and after he has passed the examination for admission to the study and practice of dental surgery before the said College of Dental Surgeons of the province of Quebec.

College of Dental Surgeons of P. Q. authorized to admit Alexis Turgeon, on conditions.

2. This act shall come into force on the day of its sanction. Coming into force.
