

## C H A P. 8

An Act to detach certain lots in the second range of the township of Tingwick, in the county of Arthabaska, from said township, and to annex them for certain purposes to the municipality of Kingsey Falls in the county of Drummond

[*Assented to 28th February, 1907*]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Lots numbers twenty-five, twenty-six, twenty-seven, twenty-eight and twenty-nine, in the second range of the township of Tingwick, in the county of Arthabaska, are hereby detached from the said township of Tingwick and from the county of Arthabaska, and annexed to the municipality of Kingsey Falls, in the county of Drummond, for all purposes, except registration purposes. Certain lots in township of Tingwick annexed to Kingsey Falls.

**2.** The limits of the counties of Arthabaska and of Drummond, fixed respectively by numbers 2 and 18 of the table of article 64 of the Revised Statutes, are changed accordingly. R. S. Q., 64, amended.

## C H A P. 9

An Act to annex the parish of St. Charles de Mandeville to the county of Berthier, for all purposes except school purposes

[*Assented to 14th March, 1907*]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The parish of St. Charles de Mandeville, in the county of Maskinongé, is detached from said county, and annexed to the county of Berthier, for all purposes whatsoever, except school purposes. Parish of St. Charles de Mandeville annexed to county of Berthier.

**2.** The concessions of Peterborough, St. Augustin, and the north shore of the river Maskinongé, at present forming part of the parish of St. Gabriel de Brandon, in the county of Berthier, are detached from the said parish and are annexed, for all purposes whatsoever, except school purposes, to the Certain concessions annexed to St. Charles de Mandeville.

parish of St. Charles de Mandeville annexed to the county of Berthier by section 1 of this act.

## CHAP. 10

An Act to detach a certain lot in the parish of St. Leonard, in the county of Nicolet, from said parish, and to annex it for all purposes to the parish of St. Eulalie in the said county

[*Assented to 14th March, 1907*]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Part of certain lot in parish of St. Leonard annexed to parish of St. Eulalie.

**1.** The north-east lateral and longitudinal two-thirds of lot number thirty-five of the cadastral plan of the county of Nicolet, for the part of the parish of St. Eulalie annexed to the parish of St. Leonard, and already canonically annexed to the parish of St. Eulalie, are annexed for all purposes to the said parish of St. Eulalie in the county of Nicolet.

Limits of said parishes changed.

**2.** The limits of the parishes of St. Leonard and of St. Eulalie, in the county of Nicolet, are amended accordingly.

## CHAP. 11

An Act to amend the Quebec License Law

[*Assented to 14th March, 1907*]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

French version of 63 V., c. 12, art. 2, par. 17, amended.

**1.** Paragraph 17 of article 2 of the act 63 Victoria, chapter 12, as amended by the act 5 Edward VII, chapter 13, section 1, and by the act 6 Edward VII, chapter 9, section 2, is further amended by replacing the words : “ ailleurs que dans le territoire couvert par sa licence,” in the last two lines of the French version, by the words : “ dans aucune autre partie du territoire couvert par sa licence.”
