

appointed teachers of the said school at St. Anne de Bellevue, of such allowance as may be agreed upon between them and the Protestant Committee, and approved by the Lieutenant-Governor in Council.

It is further agreed that this agreement shall be conditional upon the same being ratified and confirmed by an act of the Legislature of Quebec to be passed at the present session thereof.

## CHAP. 27

An Act to provide for a grant to help found and maintain a chair of surveying in the city of Quebec

[Assented to 14th March, 1907]

**W**HEREAS it is expedient to grant a certain sum to help Preamble.  
 found and maintain a chair of surveying in the city of Quebec, in order to facilitate the study of the natural and mathematical sciences, a knowledge of which is necessary to those intending to pursue the calling of surveyors.

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Annual grant of \$5,000 for chair of surveying in Quebec city. **1.** It shall be lawful for the Lieutenant-Governor in Council to grant annually to the "Syndicat Financier de l'Université Laval à Québec" a sum of \$5,000.00 to help found and maintain a chair of surveying in the city of Quebec.

Coming into force. **2.** This act shall come into force on the day of its sanction.

## C H A P. 28

### An Act respecting the Polytechnic School

[Assented to 28th February, 1907]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

57 V., c. 23, s. 17, amended. **1.** Section 17 of the act 57 Victoria, chapter 23, as amended by the act 3 Edward VII, chapter 17, section 4, is further amended by replacing the word "thirteen" in the fourth line, by the word "sixteen."

*Id.*, s. 21*a*, amended. **2.** Section 21*a* of the said act, as enacted by the act 3 Edward VII, chapter 17, section 5, is amended :

(*a*) By adding, after the word "hundred," in the third line of the first paragraph, the words "and sixty."

(*b*) By substituting for the words "a rate of interest not exceeding four per cent per annum," in the fifth and sixth lines of the same paragraph, the words "the market rate of interest."

(*c*) By adding thereto the following paragraph :

Guarantee of loans. "In order to secure the repayment of any loan payable by annuities or otherwise, it shall be lawful for the school to assign, for as many years as may be necessary, its whole annual allowance granted under section 17 ; and the lender shall not be bound to see to the application of such loan."

Coming into force. **3.** This act shall come into force on the day of its sanction.
