

**13.** The trustees may have the religious buildings insured against fire and accident for the amount of the value thereof until they hand them over to the *fabrique*. Religious buildings may be insured.

C H A P. 117

An Act respecting the building of a new church at Saint Joseph d'Alma.

[Assented to 28th February, 1907]

**W**HEREAS the trustees of the parish of Saint Joseph d'Alma have, by their petition, represented : Preamble.

That on the twenty-fifth of July, nineteen hundred and six, a decree was issued by the ecclesiastical authority of the diocese of Chicoutimi permitting the building of a new church and new sacristy in the parish of Saint Joseph d'Alma ;

That, for the purpose of executing such decree, they were elected in the manner prescribed by articles 3396 to 3402 inclusively, of the Revised Statutes :

That Saint Joseph d'Alma is a young parish, capable of great developement in the future, and it is not equitable that all the costs of building such church and sacristy should rest only upon the present parishioners and upon their immovable property whose valuation will necessarily vary in the course of years until the parish has attained its full development ;

That it is necessary to effect a loan for such purpose and to obtain special legislation in connection with such loan ;

That the freeholders have approved of the said petition ;

That the plan and specifications of the said church and sacristy have been approved by his Lordship Monseigneur Michel Thomas Labrecque, bishop of Chicoutimi ;

That it is expedient to obtain at the same time, power to construct a public hall ;

And whereas the petitioners have prayed for the passing of an act for this purpose, and it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The trustees of the parish of Saint Joseph d'Alma are recognized as a legal corporation to which the provisions Trustees of parish of St. Joseph d'Al-

of the general laws shall continue to apply, except where the same may be specially derogated from or may be inconsistent with the provisions of this act.

When vacancies to be filled.

**2.** So long as five trustees shall remain in office, vacancies occurring amongst them shall not be filled.

Assistant secretary-treasurer, &c.

**3.** The trustees may appoint an assistant to the secretary-treasurer, and exact from both a surety bond of at least five hundred dollars.

Trustees may build church, &c.

**4.** The trustees are empowered to build a church and sacristy in the said parish according to plans and specifications already approved and which may be modified by competent authority, if necessary, and also to build a public hall.

Loan therefor, &c.

**5.** To defray the cost of the said buildings, the trustees may borrow upon the security of the assessment to be imposed under this act, an amount the principal of which shall not exceed forty thousand dollars, in such manner and form as they may deem expedient and on such conditions and terms as they may consider advantageous.

Loan may be paid by annuities.

**6.** The trustees are specially authorized to stipulate the repayment of the loan by annuities covering a period not exceeding fifty years.

What annuities shall include.

Such annuities shall include interest and the fraction of the capital to be paid yearly or half-yearly, for the purpose of extinguishing the debt at the date agreed upon.

Bonds, &c.

For the payment of such annuities or half annuities, bonds or debentures, maturing every six months or from year to year until the extinction of the debt, may be issued by the trustees.

Assessment to repay loan, &c.

**7.** In order to effect the repayment of such loan, both principal and interest, the trustees may levy annually, if they deem necessary, for a period not exceeding fifty years, by act of assessment upon all the immoveables of the parish belonging to Roman Catholics, the sum required for the payment of the annuities maturing in that year, or, if they deem expedient, the annuities maturing that year and in the two following years.

Addition to assessment.

**8.** To cover the costs and deficits, a sum not exceeding fifteen per cent may be added to the amount of the assessment.

**9.** The act of assessment for moneys to be levied may <sup>Assessment</sup> make the assessment payable in a single instalment, or in <sup>how payable.</sup> two or more yearly or half-yearly instalments.

**10.** The assessment may be based upon the valuation roll <sup>Basis of</sup> then in force in the municipality or in each of the municipi- <sup>assessment.</sup> palities comprised in the parish.

**11.** The act of assessment shall be made in accordance <sup>R. S. Q.,</sup> with the provisions of article 3408 of the Revised Statutes of <sup>of art. 3408, to</sup> Quebec as amended. <sup>apply.</sup>

**12.** Every instalment not paid within thirty days from its <sup>Interest on</sup> maturity shall bear interest. <sup>instalments.</sup>

#### CHAP. 118

An Act to civilly erect the parish of Saint Ignace de Loyola de Nominigue and to authorize a loan and assessment for the building of a church and sacristy

[Assented to 14th March, 1907.]

**W**HEREAS the *curé* and church wardens of the canonical <sup>Preamble.</sup> parish of Saint Ignace de Loyola de Nominigue, in the district and county of Ottawa, have by their petition represented :

That on the twenty-third day of the month of August, one thousand nine hundred and five, His Grace Monseigneur Joseph Thomas Duhamel, Archbishop of Ottawa, canonically erected as a cure and parish, dedicated to Saint Ignace de Loyola, the territory hereinafter described, comprising parts of the township of Loranger and Montigny, bounded as follows, to wit :—On the north by the line dividing the township of Montigny from the township of Boyer, from the line dividing range one from range two of the said township of Montigny, and the line dividing the township of Loranger from the township of Turgeon to the north-east angle of the said township of Loranger ; on the east by the same line in a southerly direction between the township of Loranger and
