

dred dollars each, such stock to be issued to such amounts, and at such times as may be deemed advisable. Such stock shall be payable in such manner, within such delays and upon such notices as may be determined by a resolution of the committee.

12. The paid up stock may be transferred on the books of the club, subject, however, to the restrictions and conditions imposed by the committee. Transfer of paid up shares.

13. Each holder of said stock shall be entitled to receive Dividends, a four per cent dividend annually upon his holdings, but the holders of stock who are not members of the club, are not entitled to the privileges of the club.

14. The club may, from time to time as the committee deems advisable, redeem or purchase or pay off the whole or any part of the shares of stock, bonds or debentures or the loans upon hypothec; the shares or bonds or debentures to be redeemed or paid off, to be cancelled by the committee by the drawing of lots. Redemption of stock, &c.

15. Such redemption of stock may be made by depositing in any of the chartered banks in the city of Montreal, to the credit of the holder of such shares according to the books of the club, the amount of such shares and all dividends unpaid thereon; and upon notice of such deposit being addressed by registered letter to such holder at his inscribed address at the club, such shares shall *ipso facto* cease to exist. How effected.

16. This act shall come into force on the day of its sanction. Coming into force.

An Act to incorporate the Quebec Builders' Association

[Assented to 28th February, 1907]

Walker, Jr., plumber : The Quebec Electric Company, electricians, all of the city and district of Quebec, have prayed for the passing of an act to incorporate them, with all those who may be associated with them, under the name of "the Quebec Builders Association," for the purpose of promoting good understanding amongst its members : of endeavoring to settle amicably such difficulties and disputes as may arise amongst its members or between the latter and the public ; of securing, as far as possible, uniformity and stability in the customs and usages of those whose business it is to erect buildings or to supply materials for such work and who ply the trades connected therewith, both as regards the relations between themselves and those with the public ; of aiding in establishing and maintaining sound principles in connection with the building trade, by supplying accurate information respecting current operations and also of having suitable rooms where the members of the said association may meet in the city of Quebec ;

Whereas it is expedient to grant the prayer contained in the said petition :

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

2. The object of the corporation is to promote good standing amongst its members; to endeavor to settle amicably difficulties and disputes that may arise amongst its members; to secure, as far as possible, uniformity and stability in the customs and usages of those whose business it is to erect buildings or to supply materials for such work and who ply the trades connected therewith, in so far as regards the relations between themselves; to aid in the establishment and maintenance of sound principles in connection with the building trade, by supplying accurate information respecting current operations, and also to have suitable rooms wherein the members of the said association may meet in the city of Quebec.

3. The persons hereinafter mentioned shall constitute the board of directors for the first year of the corporation's existence: Pierre Albert Lamondé, joiner and contractor; Octave Matte, plumber; J. A. Lefebvre, marble and stone-cutter; Louis Larose, mason and contractor; Eugène Falardeau, roofer; R. H. Gale, and Babylas Vaillancourt, painter and decorator, all of the city and district of Quebec.

4. The corporation is authorized to make by-laws respecting the number and admission of its members, as well as the levying and payment of the fees, contributions and fines due by them, and the expulsion of members for the reasons and in the manner determined by by-laws.

5. No member shall be responsible for any debt of the corporation beyond the amount of the fees, contributions and fines which he may owe.

6. All fees, contributions and fines, payable under any by-law whatever, by the person thereunto compelled by such by-law, may be recovered by suit in the name of the corporation, and in such suit it shall be sufficient to merely allege and, at the trial thereof to prove, that the defendant, at the time such suit was taken, was or had been a member of the corporation and that the amount claimed was entered as due in the books of the corporation, and a certificate containing such allegation and bearing the signature of the secretary-treasurer of the corporation shall be received in all courts of justice as *prima facie* evidence of such allegations.

Power to
acquire, &c.
immoveable
property.

7. The corporation is authorized to acquire, possess and hold immoveable property in the city of Quebec for its own use, to an amount not exceeding the sum of fifty thousand dollars, and likewise to sell, exchange or hypothecate the same, and acquire others in lieu thereof for its own use, whenever deemed expedient.

CHAP. 127

An Act to incorporate the Royal Highlanders of Canada Armoury Association

[Assented to 28th February, 1907]

Preamble.

WHEREAS Lieutenant-Colonel John Carson, Lieutenant-Colonel Frank Stephen Meighen, Lieutenant-Colonel George Stephen Cantlie, Major James G. Ross and Captain Peers Davidson, and the officers of the 5th Regiment of the Militia of Canada known as The Royal Highlanders of Canada, have, by their petition, represented that they wish to be incorporated as an association for the purposes of owning and maintaining a regimental armoury in the city of Montreal, and for other regimental purposes, and that it be enacted as hereinafter set forth :

And whereas it is expedient to grant the prayer of the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
