CHAP. 129

An Act to confer certain powers on the *l'Académie de Billard Marcotte*

[Assented to 14th March, 1907]

WHEREAS *l'Académie de Billard Marcotte*, incorporated Preamble.
by letters-patent, has, by its petition, prayed for power to associate with itself certain members who are not shareholders, in consideration of an annual contribution, and for certain other powers hereinafter mentioned ;

And whereas it is expedient to grant the prayer contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. *L'Académie de Billard Marcotte* shall have power to Subscription
associate with itself subscription members of twenty one years members.
of age: such members shall be elected by the majority of the
board of directors after having had their names posted during
eight days in the rooms of the said academy.

2. Such members shall pay to the aforesaid academy an annual subscription which shall be fixed by the board of directors.

When rooms
to be open.

3. The rooms of *l'Académie de Billard Marcotte* situated in Montreal, may, with the permission of the city council of Montreal, granted by simple resolution, which permission shall be at all times revocable, be open to the members and shareholders of the academy every day from ten o'clock in the forenoon until two o'clock after midnight; except on Sundays when the said rooms shall not be opened until after one o'clock in the afternoon.

Card playing

4. The playing of cards, the selling, delivering or consuming of spirituous liquors even with a licence to that effect, shall not be allowed in the rooms of the said academy, nor shall there be a door or other interior means of communication with any other place where cards are played or where refreshments or spirituous liquors are sold or delivered, under penalty of losing all the rights and privileges hereby granted.

Coming into
force.

5. This act shall come into force on the day of its sanction.

CHAP. 130

An Act to incorporate The Canadian Nurses' Association

[Assented to 28th February, 1907]

Preamble.

WHIEREAS the persons hereafter mentioned have, by their petition, represented :

That an association has existed for some years past in the city of Montreal under the name of "The Canadian Nurses' Association," the objects of which are the mutual instruction and improvement, and the graduate professional instruction of trained nurses, the establishment of a sick benefit fund to make some provision for nurses in case of sickness or death, the regulation of the fees to be charged by members for services, and other analogous objects ;

That the said association is composed of the persons herein-after named and others, and that the incorporation of the said association would greatly increase and secure the advantages resulting therefrom ;

Whereas the persons hereinafter named have, by their petition, prayed that they and their successors may be incorporated
