

CHAP. 133

An Act to incorporate *Les Frères de Saint Vincent de Paul*

[Assented to 28th February, 1907]

WHEREAS Reverend Father Alexandre Nunesvais, provincial superior ; Reverend Father Paul Degesne and Reverend Brother Louis Guay, all of the city of Quebec, members of *l'Institut des Frères de Saint Vincent de Paul*, have by their petition, prayed to be incorporated under the name of "*Les Frères de Saint Vincent de Paul*," and whereas it is expedient to grant their prayer ;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Reverend Fathers Alexandre Nunesvais and Paul Degesne, and Reverend Brother Louis Guay, and such persons as do now or shall hereafter form part of their institute in accordance with its rules, statutes and by-laws, are incorporated under the name of "*Les Frères de Saint Vincent de Paul*."

2. The corporation shall have perpetual succession and may have a common seal, which it may modify at will.

3. The corporation may :

(a) With the assent of the diocesan authority, establish novitiates in every diocese of the Province of Quebec, take charge of schools for poor children, homes for orphans, apprentices, perseverance associations for young men of the working classes, unions, clubs, *patronages*, night refuges, and in general all works for the benefit of the poor and of the working classes ;

(b) Accept, acquire and hold moveable and immoveable property, under any title, for the purposes of its works, provided that such immoveables shall not exceed five hundred thousand dollars throughout the whole Province ; provided also, that if the said corporation shall become the owner of immoveable property exceeding the sum of five hundred thousand dollars, it shall be bound to sell such surplus within five years from the acquisition thereof, and invest the proceeds of such sales in accordance with articles 981*o* and following of the Civil Code ;

(c) Appear before the courts ;

(d) Borrow, lease, hypothecate, sell, exchange, assign or otherwise alienate, its moveable and immoveable property by

any title whatsoever, either wholly or partially, and become a party to bills of exchange or promissory notes.

(e) Make by-laws respecting its internal government and the administration of its property and modify or repeal such by-laws.

(f) Appoint officers, procurators and administrators, and define their powers.

4. The corporate seat of the corporation shall be in the city of Quebec, but it may be established elsewhere in the Province of Quebec by by-law, but no such by-law shall come into force until published in the *Quebec Official Gazette*.

5. The said corporation shall, when thereunto required, send reports of its operations to the Lieutenant-Governor.

6. This act shall come into force on the day of its sanction.

CHAP. 134

An Act to incorporate *Les Sœurs Missionnaires de l'Immaculée Conception*

[Assented to 28th February, 1907]

Preamble.

WHEREAS it has been represented by the petition of Dame Délia Tétrault, in religion Sister Marie du Saint Esprit; Dame Joséphine Montmarquet, in religion, Sister Saint Gustave; Dame Blanche Clément, in religion, Sister Saint Paul, that there exists in this Province a religious community whose members devote themselves to foreign missions and endeavor to train young girls to a religious life:

Whereas such persons have prayed the Legislature to incorporate them under the name of "*Les Sœurs Missionnaires de l'Immaculée Conception*", and whereas it is expedient to grant such prayer:

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
