**4.** The corporate seat of the corporation shall be in the city of Quebec, but it may be established elsewhere in the Province of Quebec by by-law, but no such by-law shall come into force until published in the *Quebec Official Gazette*.

**5.** The said corporation shall, when thereunto required, send reports of its operations to the Lieutenant-Governor.

## CHAP. 134

### An Act to incorporate *Les Sœurs Missionnaires de l'Immaculée Conception*

[Assented to 28th February, 1907]

Preamble.

**WHEREAS** it has been represented by the petition of Dame Délia Tétrault, in religion Sister Marie du Saint Esprit ; Dame Joséphine Montmarquet, in religion, Sister Saint Gustave ; Dame Blanche Clément, in religion, Sister Saint Paul, that there exists in this Province a religious community whose members devote themselves to foreign missions and endeavor to train young girls to a religious life :

Whereas such persons have prayed the Legislature to incorporate them under the name of "*Les Sœurs Missionnaires de l'Immaculée Conception*", and whereas it is expedient to grant such prayer :

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

porated.

**1.** Dame Délia Tétrault, in religion, Sister Marie-du-Saint Esprit ; Dame Joséphine Montmarquet, in religion, Sister Saint Gustave ; Dame Blanche Clément, in religion, Sister Saint Paul, members of the said religious community, and such other persons as now are or may hereafter become

members thereof, are hereby incorporated under the name of

"*Les Sœurs Missionnaires de l'Immaculée Conception*", for the purposes hereinabove set forth.

**2.** Under such name the corporation shall have perpetual succession, and may ; Powers of corporation.

(a) Appear before the courts ;

(b) Have a seal which it may change or renew whenever it deems advisable ;

(c) Acquire, receive and possess moveable and immoveable property of any kind whatsoever, hypothecate, sell, lease or otherwise alienate the same, and acquire others in lieu thereof ; the value of the said immoveables shall not exceed three hundred thousand dollars ;

(d) Adopt by-laws and rules for the management of the community, the management of the corporation and the administration of its property.

**3.** The said corporation may also, for the support of its principal works, engage in teaching, and, to that end, may establish academies, boarding schools and other educational establishments in the Province. Corporation may teach, &c.

**4.** Three members of the community, one of whom shall be the sister directress, shall constitute a quorum at its meetings for the passing of rules and by-laws and the administration of all the affairs of the corporation. Quorum.

**5.** The rents and revenues of the moveable and immoveable property of the community shall be expended solely in the accomplishment of its works. Revenues how applied.

**6.** It shall be the duty of the said corporation, when thereunto required by the Lieutenant-Governor in Council, to furnish a detailed statement of the moveable and immoveable property held and owned by it under this act. Statements to be furnished.

**7.** The corporate seat of the corporation shall be at Outremont, near Montreal. It may, however, be established in some other place. In such case, the corporation shall be bound to give notice, by filing a declaration in the office of the Provincial Secretary and in the office of the prothonotary of the Superior Court in the district where the corporate seat of business shall be established, and by publishing the same in a French and in an English newspaper of Montreal. **8.** This act shall come into force on the day of its sanction. Coming into force.
