CHAP. 155

An Act to authorize the Bar of the Province of Quebec to admit Frederick Parker Walton among its members, after examination.

[Assented to 14th March, 1907]

WHEREAS Frederick Parker Walton, of the city and Preamble. district of Montreal, Dean of the Faculty of Law of McGill University, has, by his petition, represented that he is a Bachelor of Acts of Oxford University, and a Bachelor of Laws of the University of Edinburgh and a Doctor of Laws of the University of Aberdeen, and that he is an advocate of good standing of Scotland, and has been so since the 16th day of July, 1886 ; and that he is desirous of being admitted as a member of the Bar of the Province of Quebec, after such examination as the said Bar shall see fit to require ;

And whereas the General Council of the Bar of the Province of Quebec has approved of the petitioner's application, and has consented to grant the petition of said petitioner ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Admission of F. P. Walton to Bar. **1.** The Bar of the Province of Quebec is hereby authorized to admit the said Frederick Parker Walton among its members after such examination as it shall see fit to require.

Coming into force. **2.** This act shall come into force on the day of its sanction.

CHAP. 156

An Act to authorize the Bar of the Province of Quebec to admit Joseph Arthur Alphonse Pigeon amongst its members, after examination.

[Assented to 28th February, 1907]

Preamble.

WHEREAS Joseph Arthur Alphonse Pigeon, notary, of the parish of St. George de Henryville, in the district of Iberville, has by his petition, represented :

That he is thirty-two years of age ;

That he followed a complete course of classical studies at the college of L'Assomption ;

That Laval University conferred upon him the degree of Bachelor of Arts ;

That he followed a course of law lectures at Laval University at Montreal for three years, and obtained from said university the degree of Licentiate in Law ;

That he was admitted to the practice of the notarial profession on the 9th September, 1900, and has practised such profession since the said date ;

That he possesses the necessary legal knowledge and experience to allow of his being admitted as an advocate, although he has not complied with the formalities respecting the admission to study and clerkship ;

That he wishes to practise the profession of advocate, and that the General Council of the Bar of this Province has approved the petitioner's request, by resolution of the 27th December, 1906 ;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
